EXECUTIVE SUMMARY

1. The purpose of this report is to present the findings and recommendations of the Panel's review into education of children in care.

BACKGROUND

- 4. Members will recall that the Panel agreed to undertake 3 or 4 reviews throughout the year. This is the final review and addressed the education of children in care.
- 5. It was agreed that the review be undertaken because evidence showed that children in care were underachieving in their education and generally performing less well than those who are in stable family settings. Members expressed the wish to explore this and in doing so, met with officers, social workers, school representatives and staff at children's residential units. The outcome of their discussions is attached at appendix A.
