BACKGROUND

4. The Panel agreed its 2012/13 work plan at its meeting on 27th June. This report provides an update on key issues relating to the work programme attached at Appendix A. Members are reminded that the work plan is a live document to be regularly reviewed and updated. Appendix A also provides an ongoing summary of issues considered together with the impacts and outcomes resulting from the Panel's work and this will also be updated on a regular basis.

ISSUES FOR CONSIDERATION

Out of Authority Budget Review Group

- 5. It has been previously reported that a sub group would meet to consider issues around overspends in the Children and Young People's Service budget particularly around costs of agency staff and external placements. The Chair and Vice-Chair met with the Chief Executive and Director of Children and Young People's Service as an initial step. The review group met on 11th September, and agreed it would focus it's discussion on Out of Authority Placements, because this area had the highest budget overspend. The review scoping form is attached at appendix B for information.
- 6. The sub group met again on 29th October, and attached to this report at appendix B is an outline of discussion from that meeting and supplementary information at Annexe 1 and Annexe 2. The Scrutiny Officer and Members of the sub-group will also provide a verbal progress update to the Panel at the meeting.

Review of Teenage Pregnancy

- 7. At its meeting in July the Health and Well Being Board agreed that in order to tackle it effectively a more holistic overview of the issue needed to be taken with a focus on quality assurance to ensure that existing preventive measures are having the desired impact in reducing Teenage Pregnancy. It was also noted that whilst an overview of the issue is the right approach for the Health and Well Being Board, key partnerships, such as the Work and Skills Board and Foundation Schools needed to be engaged to ensure that they also consider the issue of Teenage Pregnancy alongside their agendas.
- 8. At its last meeting the Panel agreed to dedicated it's January meeting to consider this issue and appointed the following Members to undertake any pre-work.

Councillors, Jane Kidd, Rachel Hodson, Tracey Leyland-Jepson and Sue McGuinness.

The Vice-Chair, Councillor Hodson met with Jo Moxon, Assistant Director for Education on Monday 29th October, and agreed the remit of the review see scoping form at Appendix C for information. A verbal progress update will be provided at the meeting.

Review of Careers Advice and Guidance

9. The Chair and Vice Chair of the Regeneration and Environment Scrutiny Panel and Councillor Hodson, Vice Chair of this Panel met with Jane Vose, Head of Service for Learner Engagement and Lee Tillman, Head of Strategy and Programmes to discuss the review. The scoping form for the review will be circulated to the Panel prior to this meeting, for information. The review has been scheduled for 11th December at a time to be confirmed.

Councillors who agreed to take part in the review, alongside Members from the Regeneration and Environment Panel are Andrew Bosmans, Tracey Leyland-Jepson, Alan Jones and Doreen Woodhouse.
