RECOMMENDED that the Statutory Qualifying Distance as set out in the Council's Home to School Transport Policy (July 2015), provide further clarity with regard to the meaning of the nearest 'designated 'entrance' of the school or college to which assistance is being considered under the relevant clause of the policy.
