Following on from our e mails last week.

I can confirm that Mr Dowie would be willing to accept the conditions below, Number 3 being amended as discussed.

Conditions:

- 1• Except for the purposes of access and egress, all external windows and doors must be kept closed during the performance of regulated entertainment and the playing of live and recorded amplified and non-amplified music and acoustic and amplified voice.
- 2• Noise from amplified and non-amplified music, singing and speech arising from regulated entertainment from the premises shall not be audible at the boundary of the nearest noise sensitive properties after 23:00 hours.
- 3• Speakers used to relay amplified music, singing and speech provided as part of the regulated entertainment shall not be positioned outside the premises (fabric of the building).except for background music and functions held in the grounds.

4• Clear and prominent signage must be affixed to all external exit doors informing customers to respect neighbouring properties and to leave the premises quietly.
