Context	Project Description (Scope)	Case for Implementation		
<ul style="list-style-type: none"> 1,264 patients were referred to CAMHS in 2014-15, with 1,113 accepted into treatment. There were 83 LAC referred into CAMHS in 2014/15. There were 105 referrals for CYP with a learning disability in 2014/15. There were 31 young people admitted to an acute mental health bed in 2014/15, which is the second highest in the region. There has been a year on year increase in referrals for eating disorders in the past five years. This is mainly females. There has been a three-fold increase in the number of CYP admitted to hospital due to self-harm from 2011 – 2014. This is in line with national averages. 12 CYP were admitted for attempted suicide in 2014/15 (Source Local transformation plan) 9 Young People placed in CAMHS Tier 4 Beds 2016 are paid for in out of area beds(5 placed to date 2017) average length of stay of approximately 101 days, Numbers higher than national average (as quoted in LTP) Placed over a wide geographical area due to lack of local sufficiency Eating disorder community service - There has been a year on year increase in referrals into CAMHS for eating disorders as well as an increase in those accessing inpatient services. Step up & down services need greater collaboration and enhanced provisions DA: The Domestic Abuse Strategy reflects the coordinated response to domestic abuse in Doncaster, led by the Safer Stronger Doncaster Partnership. It sets out a call to action and an agreed way of working with adult victims, perpetrators of domestic abuse and with any child or young person living in a household or with the consequences of domestic abuse.
