# PROPOSED REVISIONS TO THE COUNCIL'S CONSTITUTION - PART 3, SECTION VII: COUNCIL SCHEME OF DELEGATION

## **EXECUTIVE SUMMARY**

- 1. This report outlines proposed revisions to the Council Scheme of Delegation (Part 3, Section VII of the Council's Constitution) to reflect the delegations agreed by Council at its meeting on 8th September, 2008 relating to the new functions in respect of elections, changing governance arrangements and community governance, and also to incorporate the new post designations resulting from the recent senior management restructure carried out within DMBC.
- 2. Following this Committee's consideration of the proposed revisions, the Standards Committee will be invited to comment on the revisions at its meeting on 3rd December, 2008 prior to their submission to Full Council on 19th January, 2009 for final approval.

## **RECOMMENDATION**

3. That, subject to the views of the Standards Committee, this Committee recommends the Full Council to approve the proposed revisions to the Council Scheme of Delegations, as set out in Appendix 1 to this report.

#### **BACKGROUND**

- **4.** At its meeting held on 8 September, 2008, the Council agreed delegations to officers relating to additional functions in respect of elections, changing governance arrangements and community governance. Consequently, the Council Scheme of Delegations has now been updated to incorporate these changes.
- Furthermore, the Council Scheme of Delegation has been revised throughout to reflect the new post designations arising from the recent senior management restructure conducted within DMBC, as detailed in the table below:-

The proposed revisions set out within Appendix 1 highlight track changes with the former designations being struck through and the proposed new designations shown in italics.

#### OPTIONS CONSIDERED AND REASON FOR RECOMMENDED OPTION

**6.** There are no other options considered appropriate. The amendments outlined in the report arise from the need to update specific information, which the local authority should incorporate within its Constitution.

#### **RISKS & ASSUMPTIONS**

7. The proposed amendments seek to update the Council-side Functions Scheme of Delegations in order to reflect the recent top management restructure exercise. The proposed revisions, which clarify an up-to-date schedule of officer delegations, do not carry any particular risk to the Authority.

**8.** The amendments to the Constitution contained in the report are consistent with the provisions of the Local Government Act 2000, Local Government and Public Involvement in Health Act 2007 and Regulations made thereunder.
