

### To the Chair and Members of the ELECTIONS AND DEMOCRATIC STRUCTURES COMMITTEE

### REVIEW OF THE CONSTITUTIONAL PROVISIONS REGARDING RESPONSIBILITIES FOR APPOINTMENTS TO OUTSIDE BODIES

#### **EXECUTIVE SUMMARY**

This report sets out the current Constitutional provisions in respect of responsibilities for making appointments to Outside Bodies and seeks the Committees views on whether it wishes to make recommendations to the Council after seeking the Standards Committee's views on a schedule of Bodies that should be Executive appointments in the future and those which should be full Council appointments. The Committee is asked to consider this, in light of the Overview & Scrutiny Management Committee's review of the Outside Bodies appointments process during 2007 and its recommendations to the Mayor.

#### **RECOMMENDATIONS**

2. The Committee is asked to consider whether it wishes to recommend to full Council via the Standards Committee that future appointments to Outside Bodies be split between the Executive and the full Council on the basis set out within Appendices A and B and, if so, request officers to draft appropriate revisions to the local choice functions within Sections III and IV of the Constitution, for Council's consideration.

#### **BACKGROUND**

3. Since the introduction of Mayoral Governance in May 2002 and the adoption by the Council of the Constitution in respect of a Mayoral form of governance, Part 3 of the Constitution Section III "FUNCTIONS WHICH ARE THE RESPONSIBILITY OF THE FULL COUNCIL BY RESOLUTION OF THE FULL COUNCIL" and Section IV "FUNCTIONS WHICH ARE THE RESPONSIBILITY OF THE EXECUTIVE BY RESOLUTION OF THE FULL COUNCIL" have each contained a range of functions which are 'local choice' functions. In other words, the Council has discretion to decide if the function should be a full Council responsibility or the Executive's responsibility. Currently, both Sections III and IV each contain the following provision:-

The appointment of any individual –

(a) to any office other than an office in which he is employed by the authority;

- (b) to any body other than -
  - (i) the authority;
  - (ii) a Joint Committee of two or more authorities; or
- (c) to any Committee or Sub-Committee of such a body, and the revocation of any such appointment.

In respect of Section III, this is applicable where the appointment relates to a function which is the responsibility of the full Council and in respect of Section IV where the appointment relates to a function which is the responsibility of the Executive.

4. Currently, the overwhelming majority of appointments to Outside Bodies have been Executive appointments made by the Mayor in accordance with Section IV of the Constitution in paragraph 3 above.

#### **OSMC REVIEW OF OUTSIDE BODIES**

- 5. The Overview and Scrutiny Management Committee undertook a review of organisations that the Council or Executive have made appointments to in 2007/08, and made a series of recommendations to the Mayor at its meetings on 5/11/07 and 13/12/07.
- 6. OSMC made recommendations to the Mayor with regard to those organisations that it considered in future should be appointed by the Executive and those which it considered should be full Council appointments. A list of all Outside Bodies divided in to the categories recommended by OSMC is attached at Appendices A (recommended for Executive appointment) and B (recommended for Full Council appointment). The list of Outside Bodies reflecting OSMC's recommendations shown at Appendices A and B have been refreshed to reflect an updated list of all organisations that have currently been appointed to in the 2008/09 municipal year which essentially includes any new organisations that the Council has chosen to appoint a Member to, or deleted from the list are organisations that are either no longer in existence or the Council has chosen not to make an appointment to since OSMC conducted its review.

#### **OPTIONS CONSIDERED**

- 7. The Committee is asked to consider whether it supports OSMC's recommendations on the division of appointments to be made between the Executive and full Council as listed at Appendices A and B.
- 8. Should the Committee be supportive and wish to recommend this approach to full Council it is suggested that authority be given for an annual review of the list of bodies within each category to be undertaken by Officers to allow new bodies that the Council is invited to be represented on, or bodies that are no longer in existence or that the Authority no longer wishes to be represented on, to be added or deleted from the respective schedule. It is proposed that this

delegation to Officers should provide for the annual reporting of the updated list of each category to full Council for review prior to the commencement of the new municipal year in which the appointments are to be made. If the Committee wishes to support this approach, this will require revision to the local choice function provisions within Sections III and IV of the Constitution, described above, which officers would draft for inclusion in the Committee's recommendations to the Council.

#### IMPACT ON THE COUNCILS KEY OBJECTIVES

9. This report has no direct impact on the Council's key objectives. Clear responsibility and effective Constitutional provisions for making appointments to Outside Bodies contributes towards the Councils aims of 'Achieving Excellence'.

#### **RISKS & ASSUMPTIONS**

10. No particular risks are identified in this report with regard to the scope for considering Constitutional revision.

#### LEGAL IMPLICATIONS

11. The current Constitutional provisions in accordance with the Local Government Act 2000 are set out in the body of this report.

#### FINANCIAL IMPLICATIONS

12. There are no financial implications associated with this report.
