# **DEMENTIA FRIENDLY COMMUNITY – PROGRESS UPDATE**

# 1. EXECUTIVE SUMMARY

This report provides a progress update on the work programme "Working towards making Doncaster Dementia Friendly". This is an annual update following previous updates to the Panel. A timeline of these updates can be seen in the grid below.

November 2012	Overview of dementia services in Doncaster was presented to the Panel. A request was made for an in depth Dementia Friendly Communities review.
March 2013	A Dementia Friendly Communities review was presented to the Panel and 14 recommendations were made.
March 2014	A Dementia Friendly Communities progress report was presented to the Panel and progress was reported against of the 14 recommendations made in 2013.
March 2015	Dementia Friendly Communities progress update to be presented to the Panel.

# 3. WHAT DOES THIS MEAN FOR THE CITIZENS OF DONCASTER?

3.1 People with dementia and their carers/families will be less fearful and less stigmatised as a result of the community understanding dementia. This understanding supports a change in attitude and hopefully behaviour in the wider community so when faced with someone with dementia consideration and appropriate help and support can be given. This change in attitude and behaviour will help and support people with dementia to remain independent, active and valued citizens.

#### 5. BACKGROUND

- 5.1 At a meeting of the Adults and Communities Overview and Scrutiny Panel in November 2012, members were provided with a report which provided an overview of services for people with dementia in Doncaster.
- 5.2 As a result of the information the Panel made the decision to look further into the concept of creating Dementia Friendly Communities as part of a review. This review involved examining the level of dementia awareness and considered whether the people of Doncaster were sufficiently aware of dementia. It also looked at whether the town was understanding and supportive to people with the condition.
- 5.3 In March 2013 the Panel received a report on Dementia Friendly Communities following involvement by some Members working with commissioning officers on reviewing what Doncaster offered at the time. This report was received positively and Panel members supported the delivery of a series of recommendations.
- 5.4 In March 2014 the Panel received a robust and comprehensive progress report which responded to all the recommendations and identified next steps for the coming year. A request was made to investigate if dementia prevalence could be presented by Ward and a suggestion was made about improving the use of technology with dementia care and support.

# 8. **RISKS & ASSUMPTIONS**

9.1 There are no specific legal implications arising from this review. Further bespoke legal advice will be required as the Council moves forward on "Dementia Friendly" projects, particularly in the fields of contract law, funding and procurement.

# **10. FINANCIAL IMPLICATIONS**

10.1 Current funding for the Dementia Friendly Communities programme is from the Better Care Fund. For the financial year 2014/15, £100k was aligned to a series of approved activities that have been delivered and support the update in Appendix 1. Moving forward the Better Care Fund will need to approve further allocation of resources to support the Dementia friendly Communities programme.

The DDSP is co-chaired by a service user and receives the views and opinions of users and carers from a sub group known as the Doncaster Dementia Forum (DDF). The DDF is chaired by an ex carer and founder of the Doncaster charity DonMentia. Engagement and consultation in its general sense is continuous and embedded.
