DONCASTER DIRECTOR OF PUBLIC HEALTH ANNUAL REPORT 2013

EXECUTIVE SUMMARY

1. The 2013 Doncaster Director of Public Health (DPH) Annual Report, attached at Appendix A to this report, is the first since the transfer of the specialist Public Health function from the NHS to the Council in April 2013.
2. The Annual Report reflects on: the opportunities and challenges posed by the new Public Health duties in local government and what the Council and partners are doing to meet these effectively; the key Public Health challenges for Doncaster identified in the Public Health Outcomes Framework; describes progress against recommendations made in the 2012 DPH Annual Report; and makes recommendations for decision makers locally which will contribute to the improvement of Health and Wellbeing in Doncaster.
