#### **BACKGROUND**

- 4. Following the triennial review, the Statement of Licensing Policy 2011, as presented to the Committee on the 4<sup>th</sup> November 2010, was approved for adoption by Council on the 29<sup>th</sup> November 2010 and came into effect on the 7<sup>th</sup> January 2011.
- 5. Doncaster Council has won a "Highly Commended" award at the prestigious Responsible Drinks Retailing Awards in London. The award, in the Local Authority of the Year category, was in recognition of the numerous initiatives that the Council run to promote and develop a responsible drinks retailing environment throughout the borough.
- 6. Some of the initiatives highlighted were the Best Bar None (BBN) awards scheme, which works with licensees to ensure the safe and responsible management of pubs and bars across the borough. Also mentioned was the Responsible Retailer Awards (RRA), which has worked with Off-Licenses for the past eleven years to help prevent under-aged sales. Training offered through both these schemes was also praised, in particular a new course called The Essentials of Responsible Alcohol Retailing. This new course, which is aimed at anyone involved in the sale of alcohol, has been jointly developed by BBN and RRA and is currently going through an accreditation process to allow it to be used throughout the country.

- 7. Also mentioned were improvements made to taxi ranking and making taxis safer through the installation of CCTV and Doncaster Council's close links with South Yorkshire Police and Pubwatch.
- 8. Now in its seventh year, the Responsible Drinks Retailing Awards and Conference have become established as the most credible initiative for the drinks industry. Participating in the awards provides a platform to promote our efforts, reward the team and highlight our achievements.
- 9. The RDR conference and Awards took place on Wednesday 10th November 2010.
