Informal Panel Meeting - DWP Work Programme - 14th October, 2013

8. There was an informal meeting of the Panel held on the 14th October, 2013 which was attended by representatives from Serco, A4E, Job Centre Plus and North Doncaster Development Trust. The meeting was adjourned by the Chair on the basis that the Panel was not in receipt of sufficient information and that what was provided was both confusing and unhelpful to the discussions. Panel Members may wish to discuss the merits of reconvening this meeting on the 21st January, 2013 (currently scheduled for a formal panel meeting).

Update on the Access to Housing Finance Review

9. Members will recall that they undertook a spotlight review into Access to Housing Finance in February this year. Following the last meeting held on the 30th September, 2013, a response was provided by letter by Councillor Glynn Jones, Cabinet Member for Housing.
