ADULTS HEALTH AND WELLBEING TRANSFORMATION – COMMISSIONING CARE AND SUPPORT AT HOME

EXECUTIVE SUMMARY

1. This report informs the Committee of the arrangements for its consideration of a report relating to the future of the Council's provision of Commissioned Care and Support at Home Services.

Due to the complex nature of this report and the on-going work to provide all the necessary information to inform the decision making process, this report will not be publicly available until 16th May, ahead of the Cabinet meeting scheduled for 24th May. This will avoid potentially sending out an incomplete draft report to Members of the Committee.
