Box 2 DECISION TAKEN:

To authorise Doncaster Council as Highway Authority to enter into a joint legal agreement between Nottinghamshire County Council and Island Gas Limited and L. Jackson and Co Limited in respect of highway maintenance issues

Box 3

REASON FOR THE DECISION:

Give relevant background information

Island Gas Limited has applied to Nottinghamshire County Council for exploratory drilling for Shale Gas at Mission Springs. Whilst this site lies entirely within Nottinghamshire's County Councils area, the vehicle routing scheme includes highways within Doncaster MBC's administrative area.

The agreement provides for the:

Pre start baseline dilapidation survey, Regular highway inspections Engineers detailed inspection at key stages Course for recovery of incurred costs

As a consultee to the planning application, the Council commented that:

Doncaster MBC needs to be a party to the agreement so that it can enforce the terms of the agreement related to its statutory functions, with regards to protecting their own highway assets in so far as extraordinary use and Dilapidation Surveys and Dilapidation Payments.

By entering into this agreement it will provide both an audit trail and documented evidence of the actions Doncaster Council has considered and taken to protect its highway infrastructure from potential damage resulting from an increase in HGV traffic movements for a significantly high profile development using Doncaster's roads.

If damage is caused to Doncaster's roads then the conditions contained within the signed agreement will provide ourselves with the methodology for protecting our position and recovering any costs that maybe incurred in maintaining the highway due to the increase in HGV movements as a direct result development site.

Box 4 OPTIONS CONSIDERED & REASONS FOR RECOMMENDED OPTION:

If other options were considered, please specify and give reasons for recommended option

1. Option One – Not to enter the agreement

In this instance, development traffic would still access Doncaster roads, but the Council's ability to recover costs incurred as a result of the increased use would be based on statutory rights of recovery solely.

2. Option Two - To enter into the agreement

Entering into the agreement provides a mechanism whereby the Council are able to recover any costs/carry out repairs as a result of the development in an efficient and effective manner and provides for the obligations of the developer to be planning obligations and enforceable against both the developer and the land owner without having to resort to individual enforcement action for each and every repair/dilapidation.

Box 5 LEGAL IMPLICATIONS:

Section 59 of the Highways Act 1980 allows for a local highway authority for a highway to recover expenses where there is damage caused by excessive weight passing along the highway, or other extraordinary traffic thereon, against the operator. The proposed section 106 agreement which creates planning obligations on the part of the developer and land owner incorporates a mechanism where, in addition to relying on individual action in respect of each repair, also provides a process where there is a regular inspection of the roads enabling prompt action to be taken in respect of repairs The obligations will be registered as local land charges enabling more effective enforcement.
