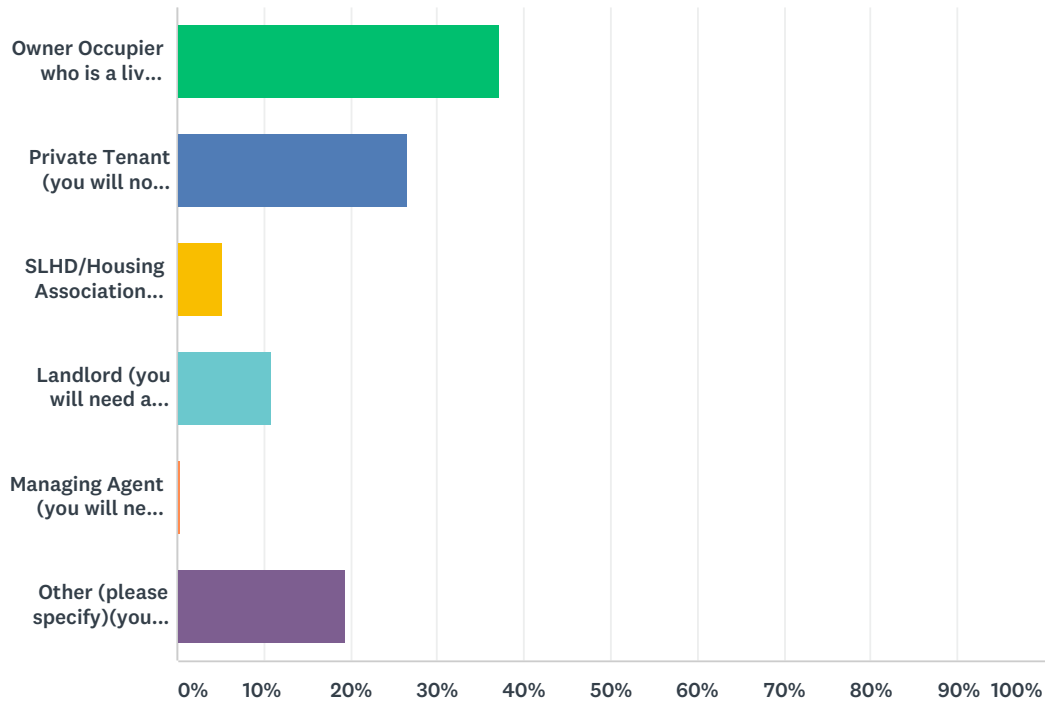

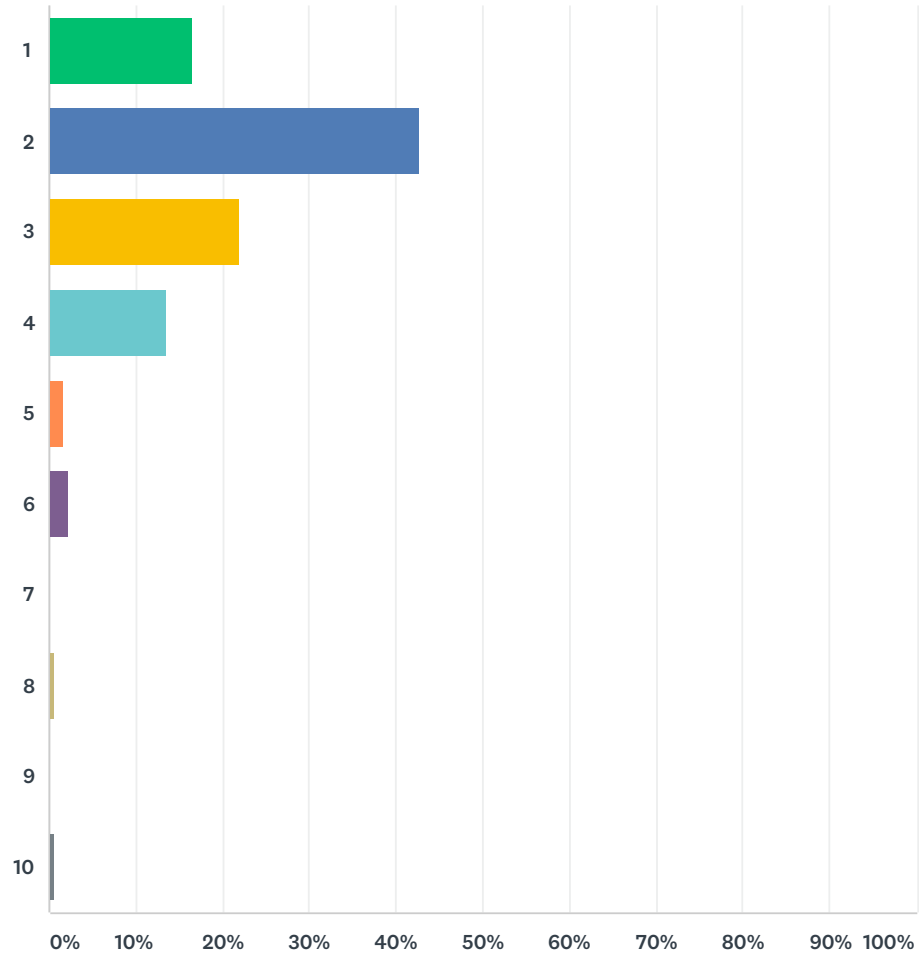

Q3 How many people live at the property?

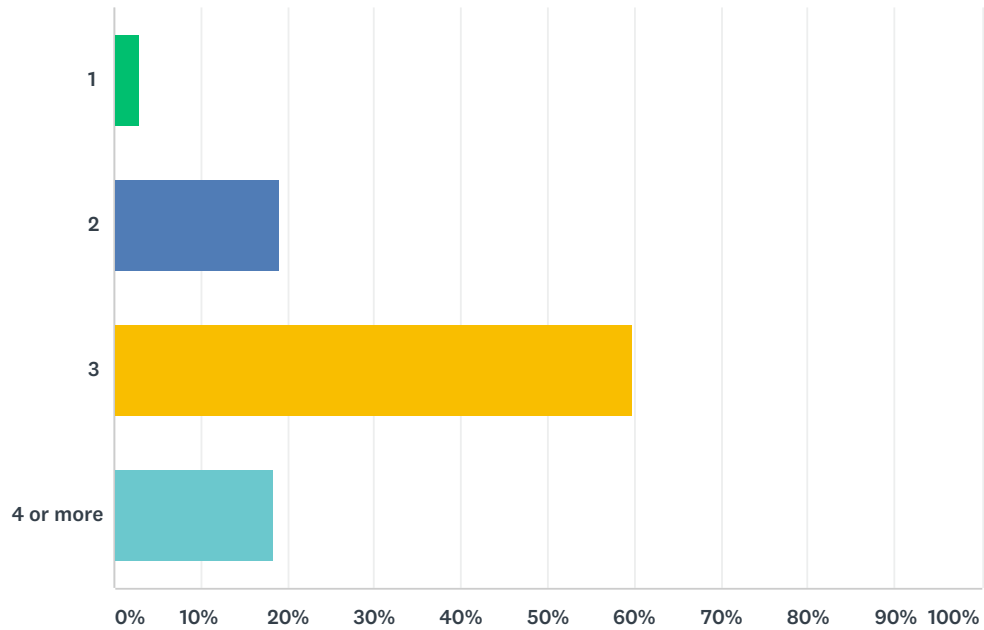

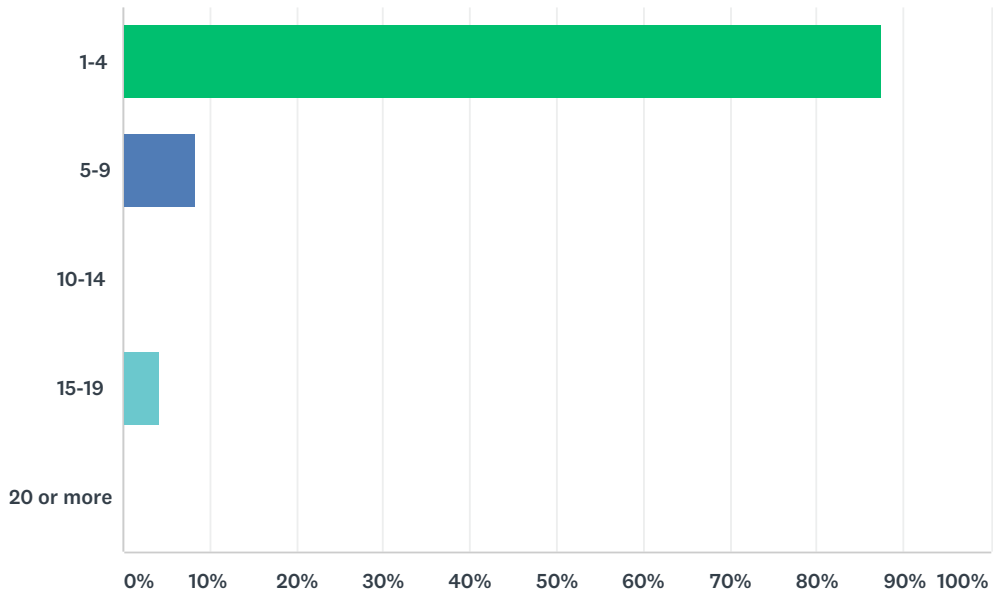

Q6 How many HMOs do you own/manage in Doncaster?

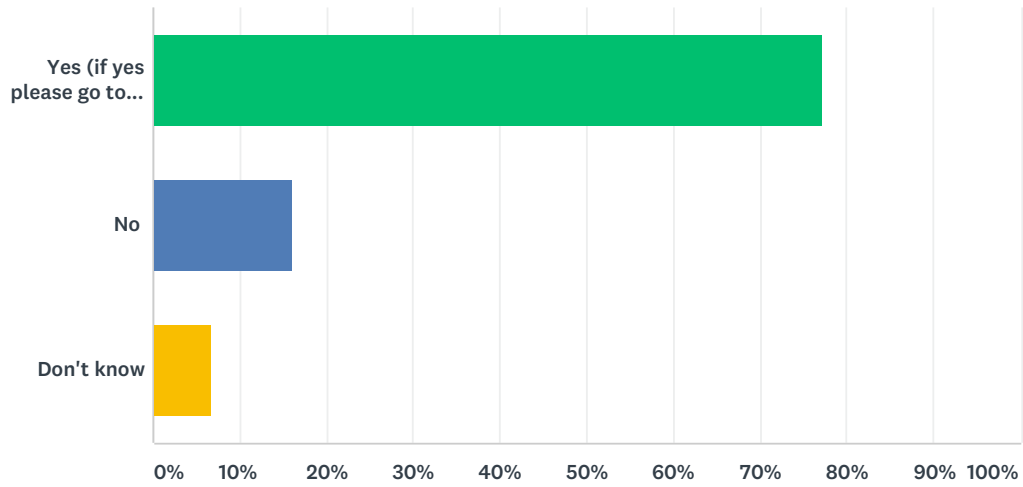

Q7 Do you think that HMO's in your area are causing a problem?

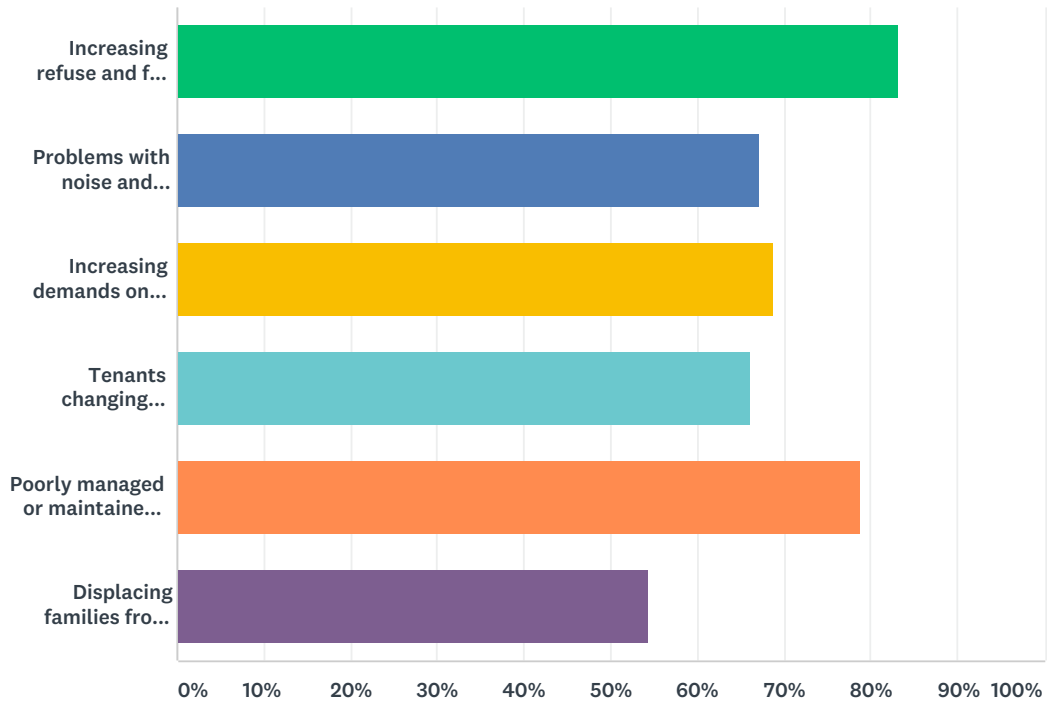

Q8 Why do you feel that HMO's have a negative impact on the area?

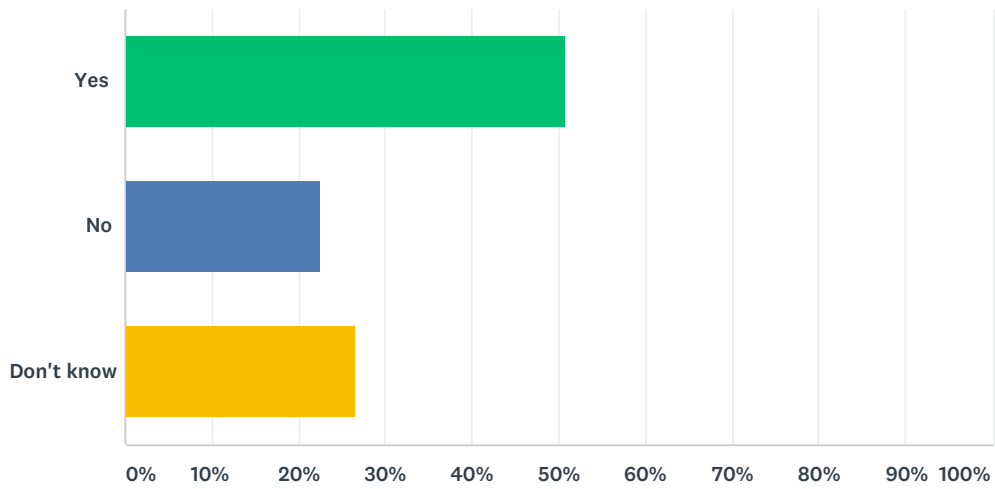

Q9 Are you aware of owner occupiers moving out of the area as a result of the problems outlined in the consultation document?

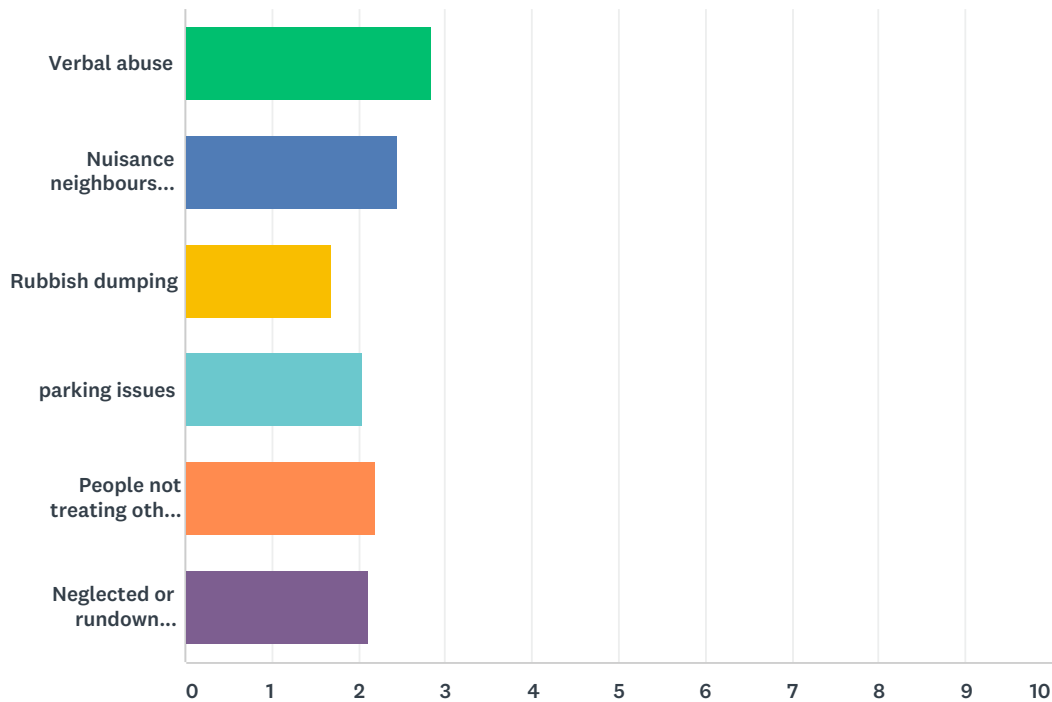

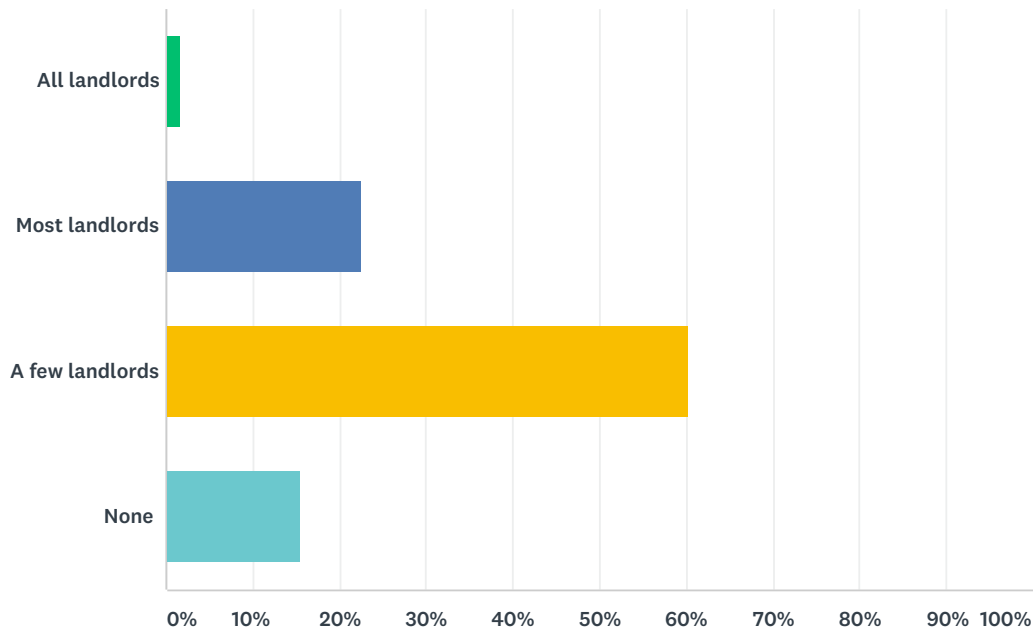

Q12 How many landlords in your area would you say are 'good responsible landlords'?

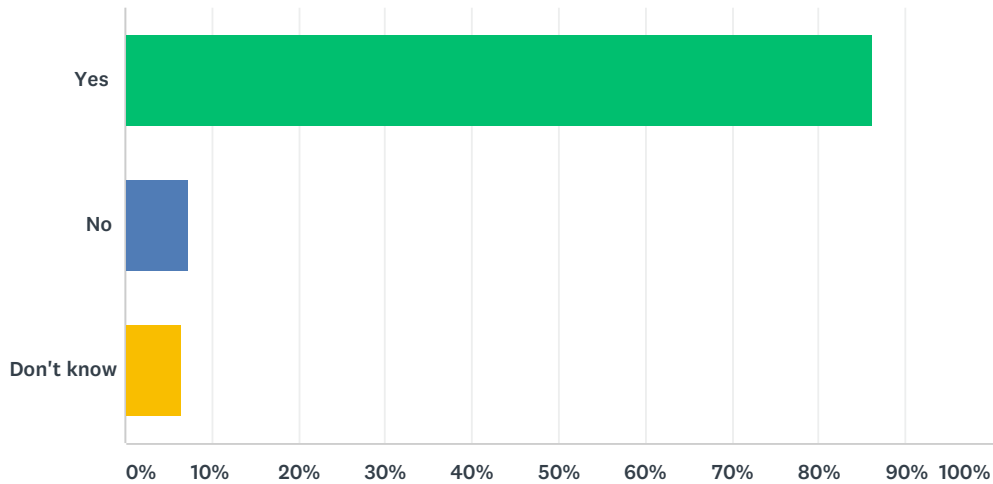

Q13 Do you agree with the Council's proposal to introduce Additional Licensing in the three central wards, as detailed in the consultation document?

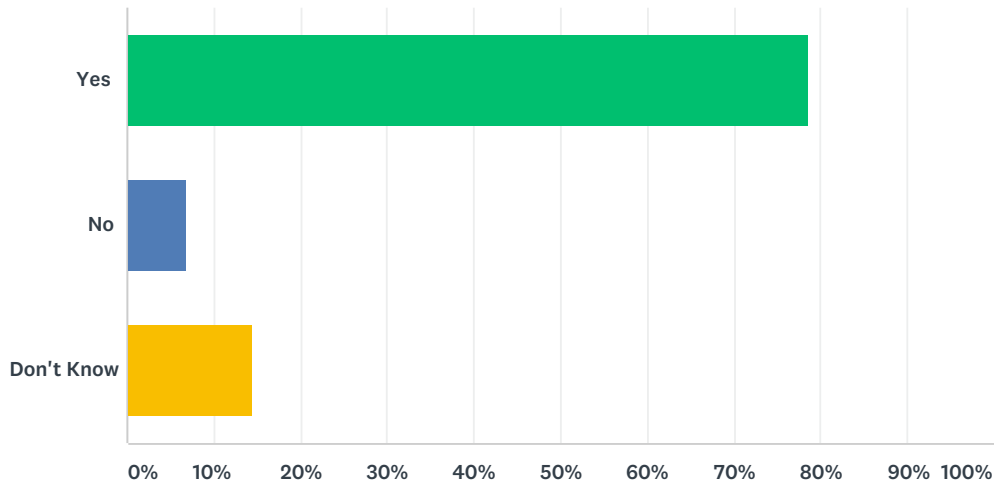

Q14 Do you agree with the Council's proposal to introduce Article 4 Direction in the three central wards, as detailed in the consultation document

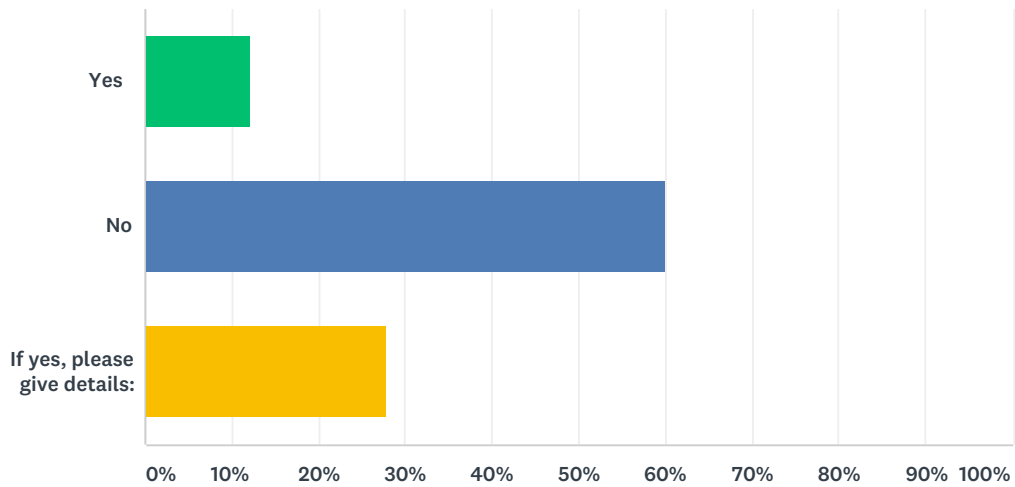

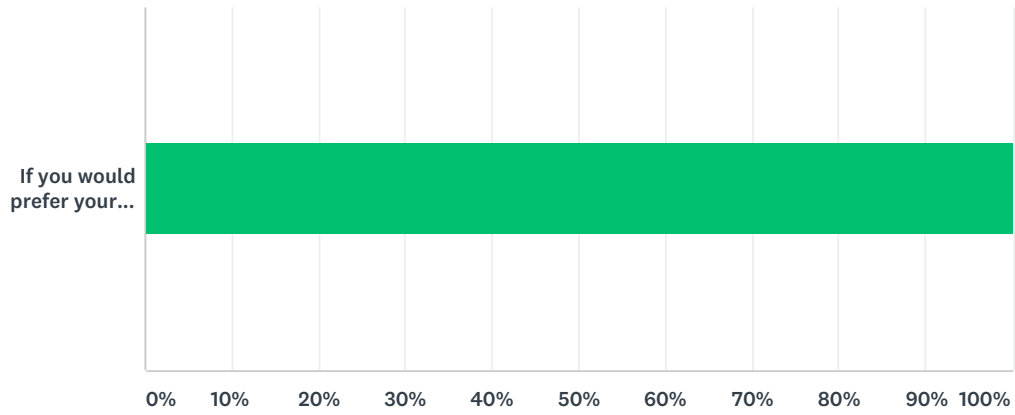

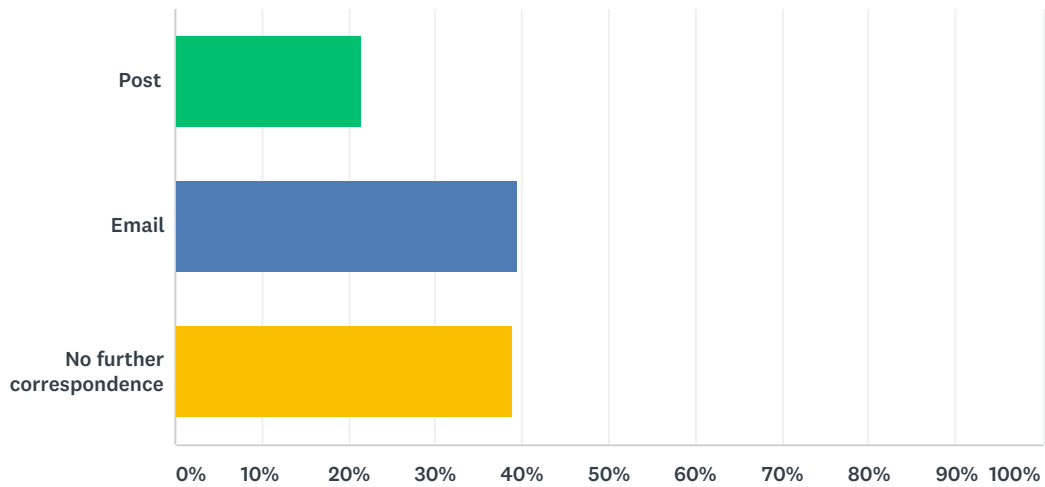
