Doncaster Growing Together (DGT) Update

Update on the DGT Portfolio Group Meeting

Partners received a presentation providing an update on DGT programmes and a snapshot of progress.

Learning Theme: The Chamber is developing a proposal to address bridging the *gaps between education and employment*. Partners discussed ideas for a *Health Campus* that not only had the potential to significantly impact on Post 16 Education in Doncaster, the development of a university city, and the recruitment of health researchers under the DGT Learning Theme; but also the local economy and environment.

'Moments to Shine'

Partners supported the basic assumption behind 'Moments to Shine': that we need to act together to make sure that the people and places furthest away from economic and social opportunity feel the benefit by: breaking the cycle of deprivation and improving life chances for our most vulnerable people, families and communities; increasing economic participation which will be key to maximising growth; and reducing demands and costs for acute public services, as a key contribution to the management of public service budget pressures. Partners endorsed the four stage approach to development of 'Moments to Shine' including prototyping of the conceptual model to identify risks and barriers at an early stage.

State of the Borough and DGT Outcomes Framework/Benefits Update

- The 2018 *State of the Borough Assessment* is due for publication in September 2018. It will provide the high level assessment of the DGT outcomes we have agreed as a partnership.
- We want to set *aspirations for DGT outcomes* by understanding the trajectory and the potential impact of programme activity. We will do this by completing analysis and consulting with primary stakeholders.
- *Benefit realisation profiles* for all DGT programmes will be defined, finalised and agreed shortly.
- A *review of how the Team Doncaster partnership structure currently operates*, after three cycles of the Doncaster Growing Together programme activity is currently being undertaken.

DGT Newsletter

The first draft of the DGT Newsletter, prepared by the Team Doncaster Partnership Communications Group has been circulated to partners.

Anti-Poverty Strategy Group – Partner Commitment Sign-Off

In signing this statement, all partners are publicly committing their organisations to the 13 actions included in the statement; and to working towards the reduction of the causes and impact of poverty in Doncaster.

Tier 1 Information Sharing Protocol

An update on progress made was presented at the meeting and any further partners who were able to sign up to the Tier 1 Data Sharing Protocol, were invited to do so by 22nd June 2018, to allow publication by the end of June.

Volunteering Hackathon

Partners endorsed and offered their support to a proposal to hold a very practical workshop where a variety of different stakeholders could come together and 'hack out' a collective solution for a volunteering brokerage platform in Doncaster, to match people's skills and time contributions to areas requiring support within the VCF sector and wider community.
