# BOX 2 DECISION TAKEN

The Council enters into a Facility Agreement with Sheffield City Council (SCC) to claim a maximum of £20,000 from the Local Integration Board Support Budget for the purposes of removing barriers or perceived barriers experienced by participants in the Sheffield City Region Health Led Employment Trial.

This grant will support the work of the LIB in addressing these barriers and adapting and responding to participant's needs, working across the entire Local Authority area and with appropriate stakeholders, in particular the private sector to open new employment opportunities.

#### BOX 3

#### **REASON FOR THE DECISION**

The Doncaster Local Integration Board was established in 2018 to:

- 1. To ensure that Doncaster's Employment and Health systems are integrated and enabling;
- 2. To provide a steer and be ambassadors for the Stronger Families Programme;
- 3. The overview of the Doncaster Growing Together (DGT) Programme and wider employment programmes;
- 4. To influence and monitor the Health and Employment Agenda with the focus on securing tangible benefits in Doncaster;
- 5. Ensure opportunities to expand pathways and interventions to support for Doncaster people are exploited;
- 6. Embed Inclusive Growth and Opportunity for All.

Local Integration Boards are a critical foundation of the emerging employment support ecosystem in SCR, providing local forums to address the many systemic issues faced by residents with multiple barriers to work. Boards will consider case examples and work together to pool resources and design out barriers faced locally. Doncaster is 1 of the 5 Local Integration Boards across the geography of the Health Led Employment Trial in Sheffield City Region. These Boards, led by Local Authorities, involve key stakeholders involved in supporting vulnerable people to overcome the many barriers they face in finding and staying in work.

Good progress has been made by the Health Led Trial in Doncaster to secure referrals, however success is also measured by the number of participants helped into employment or staying in employment. For this momentum to be maintained it will require employers to offer employment to the widest pool of local people and be supported to retain workers who may be struggling.

There is currently very little support available to employers who take on individuals with barriers to employment or for those with employees at risk of falling into unemployment. Doncaster Council submitted a Business Case, which has been accepted and approved by the Sheffield City Region Employment Programme Board. The aim is to assist them in retaining their workforce and to overcome the transitional challenges, issues and problems associated with the individual as they first find themselves in work.

The Integration Fund in Doncaster will be used to fund a campaign to:

- Raise awareness of the support available to employers;
- Help to positively change attitudes, behaviours and culture;
- Engage business and support business champions that will lead the way in the business sector;
- Increase the number of employers signing up to the Disability Confident Scheme at Level 1;
- Increase the number of employers at Disability Confident Level 2;
- Act as a catalyst to the further work and education of employers in Doncaster.
- Test, review and amend the service offered to employers.
- Create a stronger framework of responsibilities so that employers have the support they need.

A grant of £20,000 has been made available to support the development of The Doncaster Integration Board to enable it to respond to the needs of the Health Led Employment Trial as it mobilises across the Local Authority area. Funds are available for investment across 2018/19.

#### BOX 4

#### ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

**Option 1: (Preferred)**: Accept the Integration Fund monies and work in partnership with the LIB stakeholders to ensure the LIB can respond to the needs of the Health Led Employment Trial as it mobilises across the Local Authority area.

**Option 2:** Do not accept the LIB Support Budget grant award, however this will severely restrict the ability of the project partners to engage and support employers to consider extending their employment options to the benefit of people with barriers to work and continuing in work.

### BOX 5

#### **LEGAL IMPLICATIONS**

Section 1 of the Localism Act 2011 provides the Council with a general power of competence, allowing the Council to do anything that individuals generally may do. Section 111 of the Local Government Act 1972 gives the Council the power to purchase goods and services.

The Council will need to procure any goods or services bought using these funds in accordance with contract Procedure Rules and any funder requirements

In the event that the Council is required to enter into a funding agreement in respect of this project, the Council will need to comply with the terms of that funding agreement if it is to avoid clawback.
