Alcohol from an illegal source has been sold from Doncaster Food & Wine, 89 Netherhall Road, Doncaster.

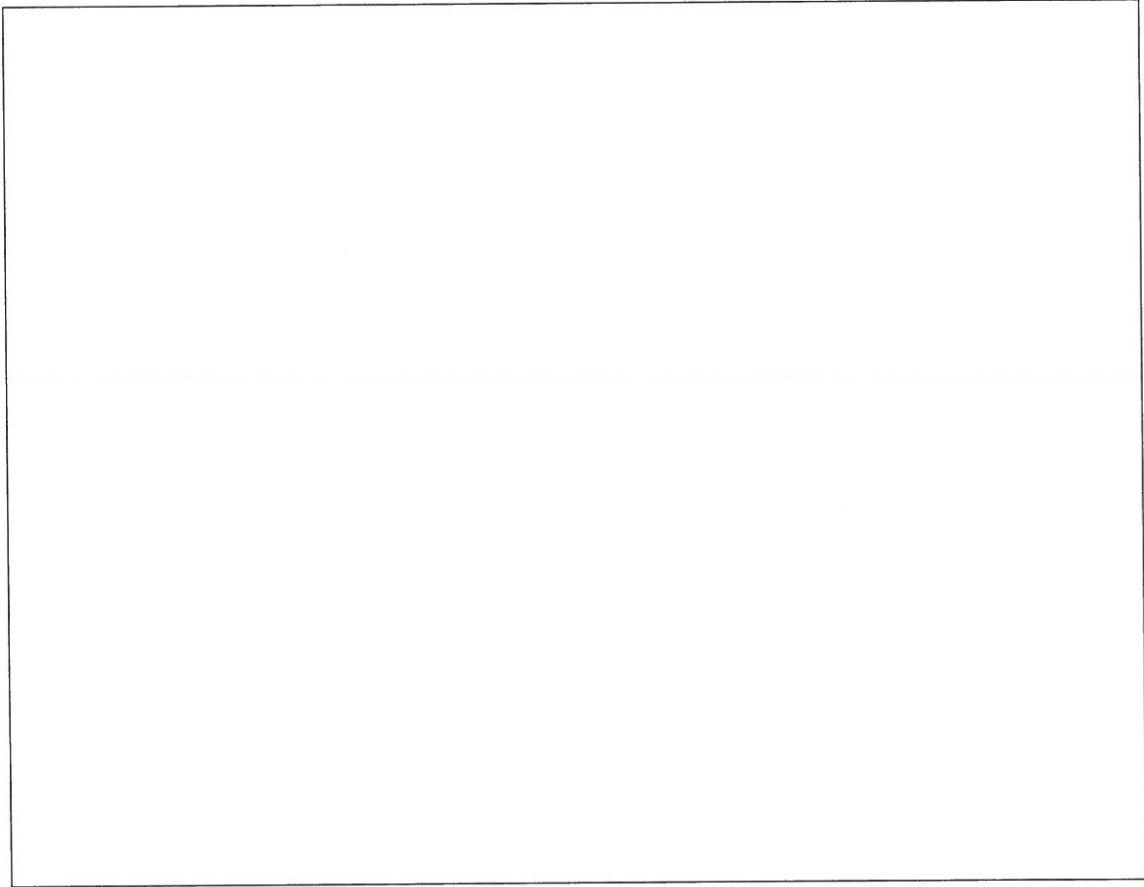
The sale of any food or drink item, including alcohol, from an unregulated source, is a direct breach of The General Food Regulations 2004 and therefore illegal. It can also not be traced to the original seller in the UK/Europe and thus could be unfit for sale or impossible to recall the alcohol if found to have a safety concern.

The alcohol on sale during the initial visit on the 29th August 2018 did not have any English labelling. This is a direct breach of The Food Labelling Regulations 2014 and does give a strong indication that the product was not manufactured for sale in England. It also did not have the correct labelling information particularly "allergens" which, would also make the product potentially unsafe for sale.

The sale of alcohol that has come from an alcohol warehouse that is not registered by HMRC under the "Alcohol Wholesale Registration Scheme - AWRS" is considered as smuggled and liable to seizure by HMRC.

The details of the AWRS scheme are included in all alcohol licences and every off licence had been written to in December 2016 & 2017 to explain the risks of purchasing illegal alcohol. Details of the scheme are also highlighted during routine visits to premises and the owner of this particular premises had been informed on several occasions verbally and in writing.

Storing "smuggled goods" on a licenced premises is a direct breach of the mandatory conditions of an alcohol licence.

On the 29<sup>th</sup> August 2018 myself, Alcohol & Tobacco Control Officer, Greg Bristol and Licensing Officer, Mr Chris Greatorex visited Doncaster Food & Wine, 89 Netherhall Road after complaints we had received relating to illicit tobacco sales. No illicit tobacco was found but on site a large amount of foreign labelled beer/larger was on sale (see attached). Mr Hadi Salem, owner and DPS could not produce any invoices for the products on sale. A formal request to produce invoices for the last 6 months and to resolve other licensing issues was sent in writing (see attached letter) and explained verbally to Mr Salem.

On the 6<sup>th</sup> September 2018 i visited the premises again with my two colleagues to see if Mr Salem could produce the invoices required. No invoices could be provided by Mr Salem for the 6 months prior to the visit on the 29<sup>th</sup> August 2018. He provided invoices for alcohol purchased after that date and stated his manager could not find the invoices from G Point 7, which is an alcohol supplier in Doncaster. We then visited G Point 7 and the company Director confirmed that Doncaster Food & Wine had only purchased spirits from them over the last six months and no polish Beer (see attached invoices).

On the 7<sup>th</sup> September 2018 myself and Mr Bristol revisited the premises again as Mr Salem had stated he had some invoices for me to see and confirmed that his CCTV system was working but he was not available and his staff member would be able to deal with any enquiries. Yet again only invoices for alcohol purchased from after the 29<sup>th</sup> August 2018 were produced (see attached) with the exception of two invoices from January 2018 from a company called "the Beer fella" (see attached). I contacted HMRC alcohol fraud investigators in Leeds who confirmed that "The Beer Fella in Sheffield" was an illegal company and had had their alcohol registration taken away in March 2018 due to illegal activity. The investigator from HMRC further explained that the company was suspected of still trading in South Yorkshire but from an unknown warehouse.

On the 13<sup>th</sup> September 2018 i contacted Mr Hadi Salem to state that HMRC was investigating "the beer fella" and explained they required further information to proceed with the investigation i.e. delivery vehicles or mobile phone contact details. He explained that the phone number used to order the alcohol did not work anymore, he had blocked the number and informed all staff not to purchase any alcohol from the premises again and could not assist HMRC any further. I left the property with no invoices for the six months sales from prior to the 29<sup>th</sup> August 2018 and explained fully that he should not purchase any more illicit alcohol and his business would be revisited on several occasions. He must provide invoices for all alcohol purchases from now on which must be registered with HMRC. Mr Salem agreed and apologised for any confusion.

On the 2<sup>nd</sup> October 2018 i received a complaint that "the beer fella" was trading in the area and was delivering today and tomorrow. Further Investigations noted that a possible delivery of illicit alcohol was delivered to Doncaster Food & Wine, 89 Netherhall Road on the 3<sup>rd</sup> October 2018. I visited the premises on the 4<sup>th</sup> October 2018 and Mr Hadi Salem was present. 16 cases of Polish Beer was in the store room (see attached). I asked Mr Salem where the alcohol had come from and explained my concerns. He stated he could not provide invoices and was unsure where the alcohol had come from. I cautioned Mr Salem and under caution Mr Salem explained that the alcohol had come from the same illegal warehouse in Sheffield and he was "tired of lying and apologised for his actions".

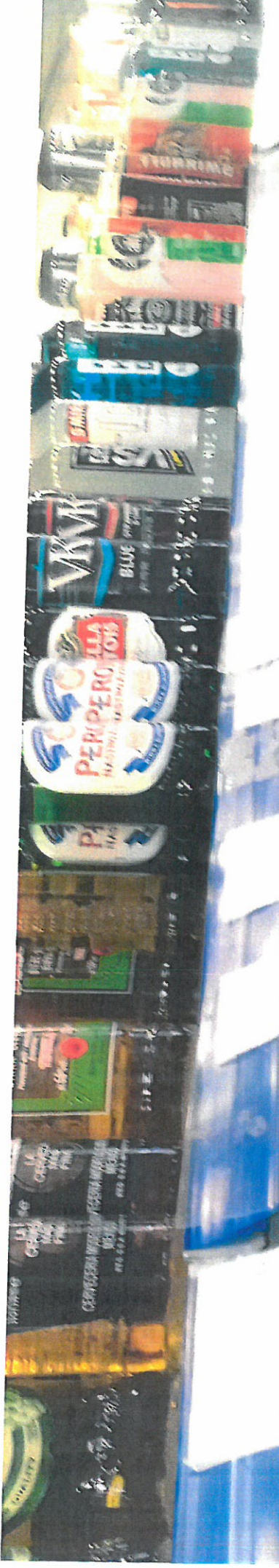

On 29 August 2018 officers from Doncaster Council inspected your premises. The following issues were discovered.

There was a large quantity of lager beer products in your stock room with some displayed for sale. You could not provide current invoices for the lager beer. Some of the products did not bear the correct information in English.

**Please supply invoices for alcohol for the previous 6 months.**

Officers asked to review your CCTV footage but found that only 18 days of footage had been saved. Your Premises Licence requires that 31 days of footage are saved.

**Please take steps to ensure that 31 days of CCTV footage can be stored.**

The inspection of your premises was in response to a complaint that illicit tobacco products were being sold from your premises. These types of products are in plain packaging and bear the correct health warnings in English. No illicit tobacco products were found during the inspection. However, I consider the complaint to be credible.

**Please ensure your staff is made aware that it is illegal to sell non-compliant tobacco products.** I would advise you to document the training that you give to your staff so that there is a record of this training.

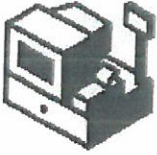
