strength (>6.5% abv) Polish lager was discovered, for which no invoices could be			
provided.			

Please provide as much information as possible to support the application (please read guidance note 2) On 29 August 2018 officers from Doncaster Council attended Simply the Best, 132 Warmsworth Road, responding to a complaint about sales of illicit tobacco products. During the inspection of the premises a quantity of illicit tobacco products was discovered and seized. The tobacco products were a mixture of coutnerfeit tobacco and cigarettes and smuggled European cigarettes. The packaging of the tobacco products did not comply with the Regulations. Illicit cigarettes are not made to the correct standards and often do not have the ability to self-extinguish, and have been implicated in house fires. A crate of Kapackie lager (9% abv) was also discovered. A condition of the Premises Licence is that no lager, beer or cider at 6.5% abv or above can be sold. The trader, Arjumand Hussein, could provide no invoices for the tobacco products or the Kapackie lager.
