NON-KEY DECISION TO APPROVE HERITAGE DONCASTER'S COLLECTIONS DEVELOPMENT POLICY.

EXECUTIVE SUMMARY

1. This report is being submitted as official approval of the Museum's Collections Development Policy.

The Collections Development Policy sets out, for the next five years, how and what the Museums will collect. The Policy has reviewed the current collections and identified areas of over and under-representation and the Policy commits to focusing on priority thematic areas for Museums in Doncaster.

WHAT DOES THIS MEAN FOR THE CITIZENS OF DONCASTER?

4. In approving a Collections Development Policy for the Museum, it means that residents can expect a well-managed resource of Museum assets, in storage, in the process of being conserved, or on display, which reflect the needs, expectations and aspirations for the public when visiting and using the Museum's resources.

BACKGROUND

5. Heritage Doncaster's Collections Development Policy is an essential requirement for Museum Accreditation, which is administrated by the Museums Association and is aligned to the Associations code of ethical practice. It is a standard policy document for Museums in England.

If Doncaster Museum and Art Gallery, and Cusworth Hall were not accredited, the service would not be eligible for funding. For example, Heritage Doncaster is currently in receipt of £100,000 per year from the Arts Council as a National Portfolio Organisation (NPO)) – an NPO is considered an exemplar in its field of work nationally - and the service could not have achieved this without accreditation status.

The policy also sets out what Heritage Doncaster's museums will and will not collect, in order for the service to have a collection which best serves and represents the people of Doncaster, and ensures that the service limits the number of objects it collects so that the service can look after a smaller number of objects to a better standard.

This Collections Development Policy was written with a public consultation into what people wanted to see in Doncaster's museums.

OPTIONS CONSIDERED

6.

- 1) To maintain a policy as in line with national sector standards, and the Museum Association's expectations, developed in consultation, ensuring the service achieves quality of provision and value for money. The policy ensures that the collections remains proportionate to the needs of service users and maintains the integrity of the collection for the borough.
- 2) To maintain collections without a current and updated policy, which may lead to increased volume of collections, increased storage requirements, and at potential increased cost.

REASONS FOR RECOMMENDED OPTION

7. Without an approved Collections Development Policy there are various risks to the service, and the adoption of the Policy ensures consistency in quality of service when benchmarked against other similar museums around the UK.

Many residents use Museums to understand the world around them and improve their lives. whether through seeing cultural artefacts and resources, learning informally, or participating in events relating to local heritage and culture. The benefits of participating in this way have proven positive impacts on wellbeing for residents. Our Museums proactively encourage and support healthy participation and activity, for example in the use of resources in museums to aide reminiscence and memory for residents living with dementia. Museums support residents with various health and wellbeing needs, and carers, through events programming and digital skills / information literacy support. This is often at no cost to residents directly. Use of museums helps children and young people to learn to think independently and gain new perspectives, which enhance skills and learning outcomes, but which can also be applied at any age of life for Doncaster's residents. For the service to work effectively for the public, a clear and robust approach to the selection, retention and disposal of collections is required.

Doncaster Learning: Our vision is for learning that prepares all children, young people and adults for a life that is fulfilling;

- Every child has life-changing learning experiences within and beyond school
- Many more great teachers work in Doncaster Schools that are good or better
- Learning in Doncaster prepares young people for the world of work

RISKS AND ASSUMPTIONS

- 9. If the Policy is not approved and made part of the service's working practice, then the following risks are presented:
 - Collections which are too large, or not reflective of demand and need
 - The development of poor records management processes
 - Museum displays which do not necessarily reflect local stories and heritage, because collections were not developed in line with a cohesive and consistent approach
 - Ineffective approach to disposals, meaning too many assets become hoarded, creating pressures on storage space
 - Reputational / PR risk, if the service was perceived to be lacking effective oversight and management of its resources
 - Possible direct detriment to the collections if too many assets are in store and on display, it is more time consuming to conserve and curate assets, leading to exposure to risk of deterioration of the asset.
 - The service may default on its duty to ensure that collections reflect the diversity of the borough's history, up to the present day and in future.

10. There are no specific legal implications with regard to this report. It is good practice to have a Collections Policy to ensure that a strategic view is taken of the collection and obtaining new items.

FINANCIAL IMPLICATIONS [Officer Initials OB Date 28/03/19.

11. Heritage Doncaster's Collections Development Policy is an essential requirement for Museum Accreditation. Doncaster Museums require accreditation in order to access external funding. Heritage Services has been awarded National Portfolio Organisation funding by the Arts Council of £100k per annum for four years (2018-22). By not extending the current collections development policy, this funding would be at risk as it states in the additional terms and conditions of the funding that museums must maintain accredited status throughout the investment period.

12. There are no obvious HR implications arising from approving this particular Policy within the Report.

13. There are no specific technology implications at this stage. However, the Collections Development Policy confirms that the service are looking to develop a digital collection. Further consultation with ICT is needed as part of the planning for this, to ensure that the storage requirements, options and implications are fully considered.

HEALTH IMPLICATIONS [Officer Initials CEH Date 20.03.19]

14. There is evidence to show that engagement in art and cultural activities can improve mental and physical health. Museums are increasingly being considered as locations for health and wellbeing activities.

Despite the many health and wellbeing benefits of the arts, cultural engagement tends to be unevenly distributed across the social gradient. Analysis of national data generated by the Taking Part survey has shown that people who visit museums and galleries are disproportionately prosperous and well-educated professionals with disproportionate representation within age, ethnicity and health status categories.

It is recommended that continual work is undertaken to understand and overcome barriers to cultural participation particularly for underrepresented groups who may already be experiencing health inequalities.

15. The Policy will help to provide an improved service to the people of Doncaster by ensuring that their heritage as conserved for and represented in Museums is cared for. The Collections Development Policy will lead to practice whereby the service focuses on working with groups with protected characteristics under the Equality Act 2010, and commits Heritage Doncaster's Museums to collecting in those areas to ensure that collections and displays properly and appropriately represent the diverse people and communities of the borough.
