BOX 3 REASON FOR THE DECISION

To ensure that the Council's interests are sufficiently represented through its appointments to these bodies.

Such appointments help to ensure that the Council's views are represented to local and national groups and, where the representative has voting rights, that the Council is involved in any decisions that may affect the people of the Borough.

Yorkshire Wildlife Park Consultative Committee

Following the recent resignation of Councillor Neil Gethin from the Yorkshire Wildlife Park Consultative Committee, there is a need to appoint a Member representative to fill the vacancy for one Ward Councillor from the Bessacarr Ward on the Committee.

BOX 4 ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

To not appoint a Bessacarr Ward Councillor as a Council representative on the Yorkshire Wildlife Park Consultative Committee. The option not to make this appointment would mean a loss of opportunity for the Council in lobbying, decision making, representing the Council's views and influencing future policy and would fail to ensure that all relevant Wards are represented on the Consultative Committee.

BOX 5 LEGAL IMPLICATIONS

Members/Officers of the Council are appointed to outside bodies in different capacities. The bodies range from incorporated bodies to Associations, Schemes and Statutory Bodies. The nature of the organisation and its constitution and nature of the appointment will affect any personal liabilities of the Members/Officers.

Members/Officers may be appointed to a body to represent the Council with voting rights or as observers. The nature of appointment will be specified in the Articles/Constitution of the organisation. In some cases, Members/Officers may be appointed as Directors or Trustees in which case they are obliged to act in the interests of the charity or company and are personally liable in the event of any breach of their duties. Where Members/Officers are appointed to Outside Bodies as Directors or Trustees or where they are expected to carry out a management function for the Outside Body, they should seek legal advice as to their duties and responsibilities and any personal liability which may accrue.
