#### **EXECUTIVE SUMMARY**

1. To accept the grant funding from the Department for Transport (DfT) to undertake the renewal and replacement of structurally deficient flagged footways with tarmac based on the challenge fund bid submitted to the DfT.

#### RECOMMENDATIONS

3. It is recommended that the grant funding from the DfT be accepted and works carried out to refurbish some of the most structurally deficient footways. The limit and extent of the work to be based on condition assessment and agreed by Cllr J Blackham, portfolio holder for highways, street scene and trading services.

# WHAT DOES THIS MEAN FOR THE CITIZENS OF DONCASTER?

4. This will help enhance the local environment and provide better and more even walking surfaces for young old and alike.

#### BACKGROUND

5. The opportunity arose in autumn 2019 to bid for money from the DfT challenge fund for specific highway maintenance projects up to £5m. The bid being supported and predicated on £0.5m supportive funding from Doncaster MBC Capital allocation. Doncaster had good supporting data from its footway condition surveys to bid for replacing failing concrete paving slab footways with flexible ones.

#### **OPTIONS CONSIDERED**

6. There are no options in connection with this report. The funding has been granted on a project specific basis.

# **REASONS FOR RECOMMENDED OPTION**

7. To maximize the benefit available for the citizens of Doncaster from the additional investment by the DfT.

# **RISKS AND ASSUMPTIONS**

9. There are minimal risks connected with the project, however the funding is minimal in terms of addressing the overall maintenance backlog. The extent of the works will be managed to remain within the funding available. Co-ordination with utilities will be undertaken as far as possible.

### LEGAL IMPLICATIONS [Officer Initials...ND..... Date...4/9/20.....]

10. Section 1 of the Localism Act 2011 gives the Council a general power of competence to do anything that individuals may generally do.

The grant will allow the Council to carry out to refurbish some of the most structurally deficient footways.

Replacement of structurally defective footways is part of the Council's obligations:

- The Council is the highway authority and therefore is responsible for those highways maintainable at public expense. The highway authority has a duty under section 41(1) of the Highways Act 1980 to maintain a highway maintainable at the public expense.
- A footway, meaning pavement or path running alongside a road used by pedestrians, forms part of the highway (Section 329 of the Highways Act 1980) and so the obligation includes maintenance of the footway as well.
- Maintenance means to "put or keep" and therefore can include replacement of the footways. The Grant will provide funds which the Council will put towards this replacement.

The Council can accept external funding in order to carry out these works. However the Grant Funding conditions (Annex B of the Specific Grant Determination) must be satisfied otherwise the grant can be suspended or repayment ordered:

- The Grant Funding conditions state that the money must be used in accordance with regulations made under s.11 Local Government Act 2003. This means the funds be used only to meet capital expenditure, or debts or other liabilities i.e. not used for every day expenses. The replacement of footways will constitute capital expenditure.
- The Grant Funding conditions require the Chief Executive and Chief Internal Auditor to sign the declaration referred to at Annex B no later than 30 September 2021 confirming that the conditions of the grant were complied with.

Where the Council secures external funding they must do so in accordance with the Financial Procedure Rules.

The appointment of any eternal contractors to carry out the works must be in compliance with the Councils contract procedure rules.

# FINANCIAL IMPLICATIONS [Officer Initials...AT..... Date...02/09/20......]

11. £4.9m of grant funding has been allocated from the Department of Transport for footway refurbishment works and can only be used for capital works. In addition DMBC will allocate £0.5m from the LTP Maintenance block carried forward from 2019/20, and the combined scheme added to the Economy and Enterprise capital programme. The bid included specific works that would be complete.

12. The grant funding is only available in 2020/21 and any balance will be returned to the DfT. The service is required to submit quarterly reporting information to the DfT, with a final return by 30/09/21 authorised by the Chief Executive and Chief Internal Auditor that the grant has been used in line with the grant conditions. Non compliance with the conditions risk part of or all of the grant being repaid.

15. Public Health supports the recommendation to accept the grant funds to undertake the renewal and replacement of structurally deficient flagged footways with tarmac based on the challenge fund bid submitted to the DfT.

The recommended improvements link to the Get Doncaster Moving Walking Strategy, which includes an ambition to improve the quality of where people walk. As stated in the report, refurbishment of the footways will provide residents with safer and cleaner paths to walk to school, their place of work or shops, as well as social walking thus improving physical, social and mental wellbeing. Through better-conditioned footways, it becomes more attractive for residents to undertake shorter journeys by walking which can help reduce high levels of road traffic, which in turn will have a positive impact on air and noise pollution and reduce social isolation.

16. There are no equality implications associated with this decision. The highway network is maintained on a priority needs basis taking account of condition, usage, risk and affordability, therefore all demographic groups are inherently considered.
