1. EXECUTIVE SUMMARY

- 1.1 This report recommends the approval of the existing Alley gates Public Spaces Protection Order for a further 3 years and details the outcome from a consultation on the proposed renewal of the Public Spaces Protection Order (PSPO) for restricting access to public rights of way with alley gates. This has generated a response from the Doncaster public and key stakeholders that is strongly in favour of the proposed prohibitions.
- 1.2 The consultation responses from residents directly affected by the proposed prohibitions, evidence that there is a clear desire to see the PSPO renewed with 100 % of all responses (529), stating they would like the order to be renewed and the gates to remain in place and closed.

2. Reason for Urgency:

2.1 The current order expired at the end of October 2020 and therefore a decision is required urgently. Work around consultation began in May 20 to collect data and consultation evidence, however it became clear that engagement and consultation results were not as expected, and this was attributed to Covid-19 pandemic and lockdown. Therefore, the consultation period was extended in order to gain a realistic and representative response from residents. This delay and uncertainty has meant that the usual 28 days' notice required for this decision could not be provided. This decision is therefore being taken in accordance with the Council's Access to Information Procedure Rule 15, General Exception.

3. EXEMPT REPORT

3.1 This is not an exempt report.

4. **RECOMMENDATION**

- 4.1 That Councillor Chris McGuiness:
- 4.2 (i) Note and consider the outcomes of a consultation on the renewal of the Alley gate Public Spaces Protection Order across the specific areas within Doncaster borough; and.
- 4.3 (ii) Approves the proposed Public Spaces Protection Order as set out in **Appendix 1.**

5. WHAT DOES THIS MEAN FOR THE CITIZENS OF DONCASTER?

5.1 The consideration of renewing the alley gate PSPO for the areas covered within the Doncaster borough, would ensure that those residents continue to feel confident that the issue remains a key priority for the Authority. The recent Doncaster Talks analysis evidences that residents want to see their neighbourhoods clean and safe, and the continuation of the PSPO will enable

the Authority to show commitment to this end.

5.2 If the order is renewed, focus will be given to refresh plans of activity; which will include renewal of older gates, education and engagement of residents about the benefits of having the gates, and wider enforcement tactics linked to tackling issues such as, fly tipping and anti-social behaviour. This in turn will clearly contribute to the vision set out within the Doncaster Living element of the Doncaster Growing Together Borough Strategy.

6. BACKGROUND

- 6.1 Alley gates are large gates installed in residential and commercial areas to restrict access to alleyways in order to reduce crime, fly tipping, prostitution and anti-social behaviour. Overall, the levels of crime and anti-social behaviour that was being experienced by residents of the above areas were excessive, and above average for Doncaster which was the reason for the initial installations. The alley gates, some of which have been installed for several years, have had a positive impact on the physical environment contributing to the feeling of safety amongst the residents, without being at detriment to the wider community.
- Alley gates continue to be a visible deterrent and assist in preventing incidences of crime and disorder, including criminal damage, burglary, antisocial behaviour, environmental crimes and restricting of alleyways is very well supported by residents and Partners. Requests for further gates to be installed are often received by Community Safety from residents, due to the noticeable impact they have had on surrounding areas. Consideration has also been given to the impact of the renewal on the wider communities. Whilst prior to the existing order, the alleyways were public rights of way they have been closed off for a significant amount of time, without any difficulties or requests for access. In all cases, other, alternative, convenient routes are available for residents via the main lighted highway.
- 6.3 The legal order to allow access to be restricted is a Public Space Protection

Order and this order requires reviewing every 3 years.

6.4 There are 248 gates across Doncaster with the breakdown by area is as follows:

7. OPTIONS CONSIDERED

7.1 The option to renew the Alley gate Public Space Protection Order for Doncaster has been carefully considered against the only alternative option, which would be to remove all gates and allow unrestricted access to the alleyways. This option would give rise to increased issues of criminality, environmental crimes and anti-social behaviour.

This option to remove all the existing Alley gates is not recommend.

7.2 Consider and approve the renewal of the PSPO in order to continue the restriction of the alleyways, to improve cleanliness and the feeling of safety for residents and the wider community.

The option to approve the renewal of the PSPO is recommended.

8. REASONS FOR RECOMMENDED OPTION

8.1 Removal of the existing gates would make the areas affected more susceptible to the crime and anti-social behaviour, which the gates were installed to reduce. Overall the levels of crime and anti-social behaviour being experienced by residents of the above areas were excessive and above

average for Doncaster. Alley gates continue to be a visible deterrent and assist in preventing incidences of crime and disorder, including criminal damage, burglary, anti-social behaviour and environmental crimes. The installation of the alley gates, which have been installed for several years, have had a positive impact on the physical environment contributing to the feeling of safety amongst the residents. The alley gates also have the advantage of preventing the access to burglars, or other trespassers from accessing the rear of properties by installing lockable gates. For all those reasons, the Council is satisfied that should a PSPO not be renewed in relation to the existing alley gates and the gates are removed, this is likely to lead to a reoccurrence of the anti-social activities in those areas, and have a detrimental effect on the quality of life of those in the locality. The Council further believes that such anti-social activity is likely to be persistent, or of a continuing nature and so unreasonable as to justify the renewal of the PSPO in relation to each of the existing alley gates.

- 8.2 There would also be the associated costs of removal and disposal of the gates in addition to associated works to the highway.
- 8.3 Renewing the order will be cost neutral to Doncaster Council.
- 8.4 Renewing the alley gate PSPO for the areas covered within the Doncaster borough, would ensure that those residents continue to feel confident that their safety and the safety of the communities remains a key priority for the Authority.

10. RISKS AND ASSUMPTIONS

10.1 There is a significant risk that should the proposed PSPO not be made in these areas and the alley gates are removed, that crime and anti-social behavior will increase in those alleys together with a corresponding increase in the fear of crime. There is also a risk of a legal challenge should the order

be made, but this risk is very low given the consultation feedback demonstrates overwhelming support for the order being made.

11. LEGAL IMPLICATIONS [Officer Initials NC Date 23/10/20]

- 11.1 Section 59 Anti-Social Behaviour Crime, and Policing Act 2014 ("the Act") introduced the Public Spaces Protection Orders (Order). The Order deals with individuals or groups committing anti-social behaviour in a public place. The Council may make or renew or vary a public spaces protection order if it is satisfied on reasonable grounds that the activities carried on in a public place within the authority's area have had a detrimental effect on the quality of life of those in the locality, or it is likely that activities will be carried on in a public place within the Council's area and that they will have such an effect. The effect of that behaviour must also be, or likely to be of a persistent or continuing nature and unreasonable such that it justifies the restrictions imposed by the order. Orders can be made for a maximum of 3 years.
- 11.2 When making a PSPO the Council may restrict a public right of way over a highway. However, before doing so it must first consider the likely effect of making the order on the occupiers of premises adjoining or adjacent to the highway; the likely effect of making the order on other persons in the locality; and if it is a through route, the availability of a reasonably convenient alternative route. In addition, before making the order, the Council must notify potentially affected persons (i.e. occupiers of premises adjacent to or adjoining the highway, and any other persons in the locality who are likely to be affected by the proposed order) of the order, inform them how they can see a copy of the proposed order, notify those persons of the period within which they may make representations about the proposed order, and consider any representations made.
- 11.3 A PSPO cannot restrict the public right of way over a highway for the occupiers that is their only or principal means of access to their home, or to access premises used for business or recreational purposes during periods when those premises are normally used for those purposes.
- 11.4 In making a PSPO that restricts a public right of way over a highway, the Council may install, operate and maintain barriers/gates to enforce a restriction in the PSPO.
- 11.5 Section 72 of the Act places a duty on Council's when considering renewing

or varying an order, and if so, how and how long for, that they must have particular regard to the rights of freedom of expression and freedom of assembly set out in the of the Convention for the Protection of Human Rights and Fundamental Freedoms. However, these are qualified rights and it is considered that in these circumstances it is legitimate to interfere with them in accordance with law and in the interests of public safety and the prevention of crime and disorder.

- 11.6 The Act also requires the Council to carry out consultation on any proposed renewal or variation of an order with South Yorkshire Police, the Police and Crime Commissioner, whatever community representatives the Council thinks it appropriate to consult and the owner and occupier of any land in the area of the proposed order. Cabinet member is advised that when considering the recommendations in this report, they must conscientiously take into account the results of the consultation and, where appropriate, having due regard to any impact on equality issues (please see the Equality Implications section of this report).
- 11.7 An interested person may apply to the High Court to question the validity of the Order, i.e. an individual who lives in the restricted area or who regularly works in or visits the area. The grounds on which an application can be made to challenge the order are set out in Section 66(2) of the Act as follows;
 - (i) The local authority did not have the power to make the order, or to include particular prohibitions or requirements imposed by the order. The Act specifically gives the Council the power to make an order and the prohibitions are lawful they are clear unambiguous.
 - (ii) That a requirement of the legislation was not complied with in respect of the order. The requirements of the Act have been followed in terms of the process that must be followed in making an order.
- 11.8 Should the proposed Order recommended by this report be made, the Council will then be required to publish it in accordance with the Anti-Social Behaviour, Crime and Policing Act 2014 (Publication of Public Spaces

Protection Orders) Regulations 2014.

- 15.1 Public Health supports the option to renew the Public Spaces Protection Order. Alley gating is a tried, tested and proven initiative that can reduce crime and anti-social behaviour. Gates have been used very successfully all over the country and is an excellent example of how partnership work between the police, local authorities and the community can proactively combat crime and anti-social behaviour. Alley gates can significantly reduce rear access burglaries and other alley related incidents. This initiative can also bring numerous immeasurable positive outcomes to health and wellbeing such as a significant reduction in fear of crime, a cleaner, safer environment and the return of community spirit and a sense of ownership and pride of the gated area. The consultation demonstrates that residents are in agreement to the renewal of the Public Spaces Protection Order.

16. EQUALITY IMPLICATIONS [Officer Initials NB Date 21.10.20]

- 16.1 In considering the proposals contained within this report, Cabinet Member is reminded of his obligations under section 149 Equality Act 2010. This section contains the Public Sector Equality Duty (PSED) which obliges public authorities, when exercising their functions, to have 'due regard' to the need to:
 - a) Eliminate discrimination, harassment and victimisation and other conduct which the Act prohibits

- b) Advance equality of opportunity between people who share relevant protected characteristics and those who do not; and
- c) Foster good relations between people who share relevant protected characteristics and those who do not.
- 16.2 Protected characteristics are age, gender, disability, race, sex, sexual orientation, gender reassignment, religion or belief and pregnancy and maternity. Only the first aim of the PSED set out in paragraph (a) above applies to a further protected characteristic of marriage and civil partnership.
- 16.3 Having due regard to advancing equality involves: -
 - Removing or minimising disadvantages suffered by people due to their protected characteristic;
 - Taking steps to meet the needs of people from protected groups where they are different to the needs of other people; and
 - Encouraging people from protected groups to participate in public life or in other activities where their participation is disproportionately low.
- 16.4 Elected members must consciously consider and have due regard to the three aims of the general equality duty when dealing with the recommendations contained within this report. The thorough and wide ranging consultation exercise undertaken in this matter has helped to inform the compilation of a comprehensive Equality Impact Analysis document, which will assist the Cabinet member in this regard, and is shown at Appendix 2. The impact of each of the proposed prohibitions has been reviewed with regard to our PSED obligations, and any negative impact on any of the protected characteristics is highlighted and addressed.
- 16.5 The Due Regard Statement is attached at **Appendix 2.**

17. CONSULTATION PROCESS

17.1 A PSPO consultation process started on 11th May 2020 and was scheduled to finish on 27th July 2020. However, due to limited responses which may be

- attributed to the ongoing Covid-19 pandemic the consultation period was extended and formally finished on 1st September 2020.
- 17.2 Residents whose properties access the alleyways and therefore directly affected by the renewal of the order, received an open invitation by letter to have their say through a variety of methods including email, telephone conversation with a member of Community Safety and completing and on line survey. The survey was not opened to the wider public due to the limited amount of properties within the restricted areas, in relation to the whole population.
- 17.3 The aim was for the consultation period to be established to enable as many residents and stakeholders the time to review the current prohibitions, and consider the need for the renewal, and secure their views and perspectives. There is no designated length of consultation period set out within the legal requirements for the Public Space Protection Order; however it was important that, given the time of year, that full opportunity was provided to those wanting to be involved.
- 17.4 Residents were asked 4 simple questions to ascertain their views on the PSPO renewal:
 - Question 1: Since the alley gates have been installed have you experiences and issues or concerns with the restricted area?
 - Question 2: Do you support the renewal of the Public Place Protection
 Order and the continuation of the alleyways being closed in your area?
 - Question 3: Do you think reopening alleyways would result in an increase of crime and antisocial behaviour?
 - Question 4: Do you have any further comments you wish to be considered?

17.5 There were 529 responses to the survey though telephone contact, email and survey monkey.

17.6 Overwhelming the residents responded with support for the renewal of the order.

17.7 Question responses:

Q1 - Since the alley gates have been installed have you experiences and issues or concerns with the restricted area?

No 60%

Q2 – Do you support the renewal of the public place protection order and the continuation of the alleyways being closed in your area?

Yes 100%

No - 0%

Q3 - Do you think reopening alleyways would result in an increase of crime and antisocial behaviour?

A little 5%

Not at all 12.5%

Q4 - Do you have any further comments you wish to be considered?

17.8 Various comments were submitted mainly focusing on the reaffirmation of support for keeping the order, some residents identified issues regarding maintenance of the gates and some residents requested further information about how to obtain keys.

17.9 Consultation was also extended to both the Office of the Police and Crime

Commissioner and South Yorkshire Police. Responses are documents below:

"I fully support the proposal to extend the PSPO in relation to alley gates in Doncaster. They have played a key part in reducing anti-social behaviour and some crime in the area and have the full support of the public."

"In my position as the Police Operations Superintendent for Doncaster, I can say that South Yorkshire Police acknowledge and support the use of the PSPO to address issues of crime and disorder. The PSPO and tactics such as alley gates have had a significant and positive effect on our ability to work in partnership to reduce crime and disorder and improve community safety in Doncaster Town Centre. Therefore, I support the proposal."

Doncaster Alleygates Public Spaces Protection Order Renewal 2020

This order is made by Doncaster Borough Council ("the Council") and shall be known as the Doncaster Alleygates Public Spaces Protection Order Renewal 2020 ("this Order").

PRELIMINARY

The Council is satisfied on reasonable grounds that the conditions below have been met:

- that activities carried on in a public place within the Council's area have had a
 detrimental effect on the quality of life of those in the locality, or it is likely that
 activities will be carried on in a public place within that area and that they will
 have such an effect; and
- the effect, or likely effect, of the activities is, or is likely to be, of a persistent or continuing nature, is, or is likely to be, such as to make the activities unreasonable, and justifies the restrictions imposed by this Order.
- And further, that the effect, or likely effect, of the activities is, or is likely to be,
 of a persistent or continuing nature such as to make the activities
 unreasonable and which justifies the restrictions imposed by this Order.
 These said activities being theft, drug use, fly tipping, urination and
 defecation.

The areas or part of the wards concerned are as follows:
Adwick Le Street and Carcoft
Edlington and Warmsworth
Hexthorpe and Balby North
Mexborough
Town

Appendix 1a details the individual alleyways including all properties effected and locations of the gates. Appendices 1b, 1c and 1d contain the plans for each area.

The Council has had regard to the rights and freedoms set out in the European Convention for the Protection of Human Rights and Fundamental Freedoms. The Council has particular regard to the rights and freedoms set out in Article 10A (Right of Freedom of expression) and Article 11 (Right of Freedom of Assembly) of that convention and has concluded that the restriction on such rights and freedoms imposed by this order are lawful, necessary and proportionate.

THE ORDER

The effect of the Order is as follows:

- 1. To restrict the use of the public right of way over the above mentioned public place ("The Restricted Areas") the restriction being in place at all times.
- 2. This restriction shall not apply to the occupiers of premises adjoining or adjacent to the restricted area so indicated.
- Access to the restricted area is to be controlled by the installation of lockable metal gates at each end of the alleyways. The maintenance of the gates, locks and keys will be the responsibility of the Community Safety, Civic Office, Waterdale, Doncaster, DN1 3BU, 01302 736000
- 4. Alternative routes to the restricted rear highways are widely available in the areas via the public highway to the front of the properties identified.
- 5. It is an offence under section 67 of this Act for a person without reasonable excuse to do anything that the person is prohibited from doing by a Public Spaces Protection Order, or to fail to comply with a requirement to which the person is subject under a Public Spaces Protection Order, and a person guilty of an offence under this section is liable on summary conviction to a fine not exceeding level 3 on the standard scale.

- 6. Access to the footpath shall be unrestricted at all times for all authorised local authority employees, the emergency services and statutory undertakers, gas, electricity, water or communication provider requiring access to their apparatus for all purposes in connection with inspection, repair and maintenance of the surface and the street lights and for any other purpose in connection with the undertaking of its statutory functions.
- 7. The Order shall have effect for a period of 3 years from the date of this Order, unless extended by further Orders.
- 8. An interested person wishing to question the validity of a Public Spaces Protection Order may apply to the High Court within the period of six weeks beginning with the date on which the Order is made.

Copies of the draft Order and map may be inspected free of charge at the Civic Offices, Waterdale, Doncaster, DN1 3BU between 09:00 and 17:00 Monday to Friday of any working week. Copies of the draft Order and maps can be viewed on the Councils website www.doncaster.gov.uk.

PERIOD FOR WHICH THIS ORDER HAS EFFECT

This Order applies to a public place within the authority's area. The effect of this Order is to impose the prohibitions and requirements detailed herein, at all times. This Order will come into force at 00:01 Hours on the 13th January 2021 and will expire at midnight on the 12th January 2024.

At any point before the expiry of this three-year period the Council can extend the Order by up to three years if they are satisfied on reasonable grounds that this is necessary to prevent the activities identified in the Order from occurring or recurring or to prevent an increase in the frequency or seriousness of those activities after that time. The Council may extend this order more than once.

APPEALS

Any challenge to this order must be made in the High Court by an interested person within six weeks of it being made. An interested person is someone who lives in, regularly works in, or visits the area. This means that only those who are directly

affected by the restrictions have the power to challenge. The right to challenge also exists where an order is varied by the Council. Interested persons can challenge the validity of this order on two grounds: that the Council did not have power to make the order, or to include particular prohibitions or requirements; or that one of the requirements of the legislation has not been complied with. When an application is made the High Court can decide to suspend the operation of the order pending the Court's decision, in part or in totality. The High Court has the ability to uphold the order, quash it, or vary it.

All residents could comprise individuals from any of the protected groups referenced here.

At Doncaster Council, promoting equality of opportunity, eliminating discrimination and building cohesive and inclusive communities is about making life better for our residents, service users, customers and employees.

The alleyways to the rear of properties in the above areas have for a number of years been facilitating anti-social behaviour including alcohol and drug misuse, fly tipping, burglaries and prostitution. This has affected the well being of the local residents who cover all demographics.

Residents report to the local nieghbourhood team and at the local PACT meeting that they feel initimidated and fearful when using the alleyways. Therefore these alley are not utilised for their intended purpose, as residents avoid using them.

The continuation of resitriction to these alleyways will help reduce the fear of crime and antisocial behaviour: this will raise community confidence of all residents who live within the area the restrictions will cover.

As all residents whose properties will be enclosed by gating the alleyway have received a key allowing them access to the alleyway. Accessibility is reviewed regularly when a resident makes contact with the Council however at any point the residents can highlight issues with accessibility and should a resident not be able to use a key or operate the gates adjustments can be made to accommodate their needs including electrifying the gate to work with a fob, adding additional support to the structure of the gate to make it easier to operate and allowances for non household members (carers, support staff etc) to have additional keys.

There is a potential negative impact on disabled and or elderly resident who may struggle to operate large gates. However we have given every consideration to this and have made alteration to the gates which include wheels, weight supports and upon request electronic modifications. This increases the ease of use for the gates.

Whilst we acknowledge that a small number of residents may have difficulty operating the gate the positive aspects of the gates being installed eg reduction of crime, antisocial behaviour and fly tipping as significant.

Resident will be made aware of how to report any difficulties using the gates through the customer service processes currently in place.

4 Summary of the consultation/engagement activities

PSPO consultation process started on 11th May 2020 and was scheduled to finish on 27th July 2020. However due to limited responses which may be attributed to the ongoing Covid-19 pandemic the consultation period was extended and formally finished on 1st September 2020

The aim was for the consultation period to be established to enable as many residents and stakeholders the time to review the current prohibitions and consider the need for the renewal and secure their views and perspectives. There is no designated length of consultation period set out within the legal requirements for the Public Space Protection Order; however it was important that, given the time of year, that full opportunity was provided to those wanting to be involved.

Residents of Doncaster received an open invitation by letter to have their say through a variety of methods including email, telephone conversation with a member of Community Safety and completing and on line survey.

5 Real Consideration:

Summary of what the evidence shows and how has it been used

The introduction of Public Space Protection Orders is derived from Central Government legislation as part of the Anti Social Behaviour, Crime and Policing Act – this is not a local decision. This order replaced the Designated Public Place Order, Gating Orders, and Dog Control Orders.

Doncaster already enjoys a wealth of established and robust multi-agency processes, all of which are victim-centred. Partners locally are confident that existing partnership resources and structures are already suitable to accommodate all required activity in respect of Public Space Protection Orders.

The framework to accommodate the process of implementing a renewed PSPO will operate within existing, robustly tested multi-agency mechanisms, which already take into account the individual requirements of victims, many of whom are vulnerable with complex needs, to ensure fair, accessible treatment and services.

The consultation exercise undertaken in this

matter shows overwhelming support for the proposed order, and no information has been received during that exercise pointing to any negative impacts from the making of the order.

Negative - There is a potential negative impact on elderly residents who may struggle to operate large gates. However we have given every consideration to this and have made alterations to the gates which include wheels, weight supports and upon request electronic modifications. Disability Positive - the order should have the impact of mitigating against crime and antisocial behaviour and reduce the fear of crime amongst disabled people.

Negative – There is a potential negative impact disabled residents who may struggle to operate large gates. However we have given every consideration to this and have made alterations to the gates which include wheels, weight supports and upon request electronic modifications. This increases the ease of use for the gates.
