BOX 2

DECISION TAKEN

To approve the receipt of an additional £72,000.00 capital grant from the Home Office Safer Streets Fund, through the Office of the Police and Crime Commissioner. This will be added to the existing funding already in place for further improvements within the original scheme which has commenced in Doncaster.

To include this additional Safer Streets funding in the Adults, Health and Wellbeing capital programme.

BOX 3

REASON FOR THE DECISION

Doncaster, as part of a joint bid with South Yorkshire Police (SYP) and the Office of the Police and Crime Commissioner (OPCC) successfully secured an initial £547k funding from the Home Office Safer Streets Fund which was authorised through a Key Decision signed by Mayor Jones on the 1st October 2020.

The original authorisation has enabled the scheme to commence within the target area of Hexthorpe with a completion date set of the 31st March 2021.

The scheme includes a range of crime prevention focused investment within the area and has already involved local residents in the decision making process for elements of the deliverables. The initial scheme included –

- Replacement alleygates
- Improved street lighting
- Installation of an additional 10 CCTV units
- Replacement bollards

- Replacement of existing street name plates
- Removal of existing brick planters
- Targeted crime prevention measures to identified residents

As the works commenced within Hexthorpe, both the Local Authority and SYP were recently contacted by the OPCC, as the Home Office had additional monies remaining in the Safer Streets Funding pot. We were asked to consider additional improvements that would complement the existing scheme.

Following consultation with Elected Members, Portfolio Lead and the relevant Doncaster Council services it was agreed that a full upgrade to the existing CCTV system within the area to a gold standard, would provide the most effective support for that community.

It was agreed that these new systems would not only provide a better and enhanced quality of surveillance and support the aim of improving the feeling of safety for residents within the neighbourhood, but also support the partnership in tackling some of the key issues including environmental crime which blights the area.

Due to the differing ages of the existing CCTV system, the ability to use a uniformed approach to replacing them with all new, high specification cameras within the dedicated area was welcomed. The failure of older cameras is already being seen and would potentially leave weak points in the coverage of this locality.

The total amount of £72k additional funding would therefore be added to the existing allocated budget for CCTV improvements from the original bid, to enable a uniformed improvement scheme to be implemented across the full extent of the designated Safer Street area within Hexthorpe.

This system would continue to link back to the Doncaster Council CCTV suite and enable live coverage as set out in the original scheme. In addition, a maintenance plan would also be included to cover the system for 5 years.

Confirmation has been received from the Community Safety team that this work is achievable and would be completed by the deadline date, which remains the 31st March 2021.

South Yorkshire Police have also been successful in securing funds to install Automatic Number Plate Recognition (ANPR) cameras to both entrances into Hexthorpe. This will bring further additionally to complement the enhanced CCTV scheme. SYP are responsible for delivering this element of the funding directly.

BOX 4 ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

Option one

Do not accept the additional funding – this is not viewed as a viable option as the continued levels of crime and anti-social behaviour including fly tipping are not acceptable. In addition the current CCTV systems in place are all of differing ages, with some already starting to fail, therefore without this funding there would be key gaps in coverage.

Option two

Accept the additional funding amount of £72k to complement the existing Safer Streets scheme – this will enable a gold standard uniformed CCTV system to be installed within the area.

The recommended option is the second option, as this would provide the greatest opportunity to overhaul the whole existing system to a uniformed high specification CCTV network. It also enables any existing cameras of good condition to be relocated outside of the designated Safer Streets zone to support residents in these wider parts of Hexthorpe who feel the addition of CCTV would improve their feeling of safety.

The acceptance of this funding would also support the ongoing partnership plan in place for Hexthorpe, further enabling the ambitions and recommendations identified within it to be taken forward.

BOX 5 LEGAL IMPLICATIONS

Section 1 of the Localism Act 2011 gives the Council a general power of competence to do anything that individuals may generally do.

Legal Services provided advice on the original grant terms and the report author should seek further advice in relation to any amended terms. As before any spending required must be undertaken in compliance with Contract Procedure Rules and funder requirements.

The report suggests that the original completion date of 31 March 2021 will be met in relation to this additional work, although it is advised that the decision maker assures themselves that this date can still be met given the changed circumstances of the January 2021 Corona Virus restrictions.

BOX 6 FINANCIAL IMPLICATIONS:

<u>Capital</u>

Doncaster Council secured an initial grant of £547k for the Hexthorpe Safer Streets scheme which was approved as a key decision on 1st October 2020. This was also approved by the Chief Finance Officer per Financial Procedure Rule B.9 as an in year addition to the capital programme of £481k, the remaining £66k element relates to revenue. The additional funding identified in this ODR will be added to the existing capital scheme subject to approval, thereby increasing the Safer Streets capital scheme to £553k

The receipt of the additional grant funding is subject to Financial Procedure Rule E.9 as follows:

E.9 Directors are authorised to apply for external funding, in consultation with the CFO, which contribute to the delivery of Council services or achievement of Council goals. Grant acceptance and/or commitment is subject to key decision rules.

The total capital cost amount of £72k is to deliver CCTV improvements identified in the body of this report. The proposed grant will be funded from the Home Office Safer Streets Fund, through the Office of the Police and Crime Commissioner.

The conditions of the grant state that all grant funded activity must be delivered by 31 March 2021 and all expenditure must be completed by 31 March 2021. This is a very tight deadline and the service will need to ensure the timescales are managed in accordance with the grant conditions in order to avoid the council incurring costs that they are unable to claim for.

The on-going maintenance will need to be met by existing budgets.
