**Subject Matter:** Increasing the level of resource supporting the re-engagement of children and young people who are missing education or whose parents have opted to electively home educate them.

### BOX 2

### **DECISION TAKEN:**

The current pandemic has created or exacerbated a growth in mental health and wellbeing needs across children and young people in the borough. The wider return to school marked a clear growth in anxiety amongst young people. And has resulted in an increase in attendances at A&E. National data from Young Minds corroborates this picture, with a similar rise in cases nationally. This highlights a clear need to support the most vulnerable children and young people in our community, providing focus around Social, Emotional and Mental Health (SEMH) needs.

The pandemic has also seen a significant rise in the numbers of children and young people missing education and being electively home educated. Local data shows a 220% increase on the same period in 2020. We know that in both these instances on average the life chances of the CYP is impacted. The absence of these children from the schools system limits our collective ability to support them, both from an educational perspective, obviously but also from a health and wellbeing perspective as warning signs are not picked u.

Wellbeing sits at the heart of our services and ambitions to become the most child friendly borough, therefore we need to address the current gap in service to support the growth in mental health and wellbeing needs across children and young people our communities.
