BOX 2 DECISION TAKEN

To agree with the recommendation from Joint Commissioning Operational Group (JCOG), approved by Joint Commissioning Management Board (JCMB) on 15th December 2021, to provide a further 12 months funding of £260k for a contract extension of the existing Social Prescribing Service. This is due to commence from 1st April 2022, from the Non-Recurrent Better Care Fund (BCF) Earmarked Reserve.

This decision is subject to all partners reviewing the strategic review and collaborating to ensure a co-ordinated system approach to social prescribing moving forward.

This decision is in accordance with recommendations made in a Cabinet Report dated 27th March 2018 which approved the spending plan for the non-recurring BCF Ear Marked Reserve as set out in the report: and delegated detailed spending decisions for the implementation of the Doncaster Place Plan £3m, other Integrated Functions £0.7m and unallocated balance £0.7m, to the Director of People in consultation with the Chief Finance Officer and relevant Portfolio Holder.

BOX 3 REASON FOR THE DECISION

Social Prescribing is defined as a means of enabling medical services to refer patients with social, emotional and/or practical needs to a diverse range of local non-medical sources of support within the community often provided by the voluntary and community sectors.

The main aims of social prescribing are to:

- Facilitate access to a diverse range of support services that enable individuals to significantly improve their health and wellbeing.
- Release specialist capacity across the system, so that individuals with the most intense health and social care needs can receive the care they require despite funding constraints.
- > Encourage and support the promotion of self -care to help people with long term conditions
- > Reduce the number of General Practitioner visits.
- Increase the capacity and capability of the Voluntary, Community Faith Sector in the provision of services.

Doncaster's Social Prescribing Service was launched as a pilot in 2015 as a joint venture between South Yorkshire Housing Association (SYHA) and Doncaster CVS. Since early 2017, the service has been delivered by SYHA. The number of eligible and onward referrals has increased significantly year on year. A contract extension was granted in October, 2020, however a combination of the departure of staff and the pandemic delayed the strategic review arrangements, thus the need for a further extension.

There is a robust body of evidence that demonstrates that social prescribing offers significant benefits to patients and health and social care professionals. Social Prescribing is a critical component of a wider transformation programme that aims to streamline patient flows through the health and social care system. Without the service, consultation slots with statutory providers will continue to be heavily used by clients who fundamentally require non-clinical/non-specialist support

BOX 4 ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

Option 1 – Do Nothing: If funding is not authorised then there is an increased risk to individuals, increased referrals to GPs, an impact on the commitment and objectives included in the Doncaster Place Plan and an impact on the ability to meet legal obligations as set out in the Care Act. If the service was removed or reduced, data suggests that there would be a disproportionate negative impact on carers.

Option 2 – Approve funding for a further 12 months of $\pounds 260k$, which will enable the provider to develop a clear exit strategy. **(Recommended)**

BOX 5

LEGAL IMPLICATIONS

Section 1 of the Care Act 2014 ("the Act") places a number of duties on the Council to promote an individual's wellbeing. Section 3 of the Act states that the Council must ensure that care and support provision is integrated with other health provision and health related provision where it will promote the wellbeing. Section 6 of the Act states that the Council must co-operate with each of its partners and each relevant partner must co-operate with the Council in exercise of their respective function relating to adults with needs for care and support.

Section 1 of the Localism Act 2011 gives the Council a general power to do anything that an individual may generally.

The decision to extend the existing social prescribing service will assist the Council in meeting the above-mentioned duties.

BOX 6 FINANCIAL IMPLICATIONS:

This ODR Waiver seeks approval of additional BCF funding for 12 months to enable a 1 year extension the costs are £260k for the 12 month period April 2022 – March 2023. Approval was given at the Joint Commissioning Group meeting on 30/11/21 to enable the continuation of the existing social prescribing contract with South Yorkshire Housing Association, for staffing and infrastructure with a value of £240,000 pa, also £20,000 pa for onward referrals to voluntary community sector (12 month period

This scheme will be funded from the Better Care Fund Earmarked Reserve as part of the Place Plan.

The BCF earmarked reserve plan for 2022/23 has been drafted and was approved at a virtual JCMB meeting on the 16th December 2021
