1. Matters arising:

A verbal update was given on the following items discussed at the March 23 Team Doncaster Executive:

- **Doncaster Remake Learning Festival** - The festival took place between the 25th May and 3rd June 2023. The launch event at Doncaster Gallery, Library and Museum (DGLAM) saw over 2000 people attend, which was great to see. An evaluation is underway and looking at potential 2nd year of the festival.
- **National College for Advanced Transport & Infrastructure (NCATI)** - Since the announcement, alternative models of delivery are being explored. Continue to work with partners including Birmingham University and DfE to look at the future use of this asset.

2. Integrated Care Board:

Members received an update on the following points:

- **Joint Forward Plan** - Work is underway to review the plan in collaboration with wider partners. The plan focus will be:
 - Prioritising the recovery of core services and productivity
 - Return to delivery of the key ambitions in the NHS Long Term Plan (LTP)
 - Continue transforming the NHS for the future
- **Industrial Action** – Continue to work through and manage the impacts of the latest three days of junior Doctor industrial action. The industrial action risks continue, with Doctors in Training scheduled to take their next action across three days. (14 to 17 June)
- **Performance Headlines** including A&E Waiting times, treatment waiting times etc.
- **Primary Care Access Recovery Plan** - has been published. The focus is about getting patients through to the general practice to get the help needed. The immediate action is to upgrade the telephony system.
- Planning is underway to celebrate the NHS turning 75.

3. Sub Regional updates:

Partners were also given an update which covered the following items.

- South Yorkshire Mayoral Combined Authority update
- Doncaster Sheffield Airport Update

4. Bus Service Review:

Members of the Team Doncaster Executive were given an update on the latest position on bus services in Doncaster and more broadly across South Yorkshire. This included an update on the latest position with national government funding to support services for the remainder of 2023 and beyond. An action was taken to coordinate a local response to the engagement, providing insight into the consequences of changes to the bus network and how it affects communities in Doncaster.



5. Team Doncaster Coordinating Group (TDCG):

Partners received an update on the focus of the TDCG over the last two meetings, this included:

- Introduction of a **Partnership update item** to give members some space and time to share information about what is happening within their own organisation (good news, areas of concern and if the partnership can help in anyway).
- An overview of the **Doncaster Economic Strategy** delivery plan since approval. Going forward meetings with other partnership boards will be taking place to understand how they can help with the delivery of the strategy and to develop joined-up work programmes.
- A lot of work has been taking place by all delivery groups to complete **2022-23 Annual Assurance Statements**. The statements provide assurance by celebrating our year one delivery, outlining remaining issues and identifying common themes. This information will be used to compliment the **Year 1 Doncaster Delivering Together annual report** along with the outcomes assessment and the inclusion of the resident voice/lived experience. Alongside this Delivery group have developed their **2023-24 TD Summary Agreements**, which contains key deliverables, key outcomes, performance measures and risks over the next year.
- All this information was used to carry out a review of delivery groups and which groups would be included in the **Year 2 'In-focus'** which now includes:
 - Economy (previously in focus)
 - Environment (previously in focus)
 - Education & Skills
 - Homelessness

Additional to this, there were a couple of delivery groups who will be asked to provide an update to TDCG within the next 6 months:

- Culture
- Children, Young People Executive

The remaining '**Other**' Delivery Groups can escalate issues throughout the year to TDCG as required.

6. Fair and Inclusive

There are several key pieces of activity currently underway that contribute to the delivery and progression of the Fair and Inclusive Well-being goal in DDT. Partners were given an update on activity which covered the following items:

- Be Kind campaign
- Care Experience protected characteristic
- Inclusion & Fairness Forum
- Black Leadership Group Anti-Racism Training
