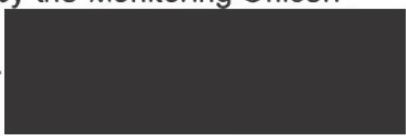

2. You must within 28 days of becoming aware of any change to the interests specified above provide written notification to the Council's Monitoring Officer of that change.
